QUESTIONS AND ANSWERS

Question 1: I noticed in the bid documents, WCB and COR is required. Is proof of this required to be submitted with the bid?

Answer 1: We will support changing it so that the bid can be submitted at this time, but that the bidder must provide proof of Alberta Worker’s Compensation Board (WCB) account in good standing, and proof of Alberta Certificate of Recognition (COR) prior to contract award.

2) On page 12 of 42, in section 5.1.3.3 Other Certifications and Licenses, insert the following at the end:

- A current Alberta Worker’s Compensation Board (WCB) document confirming their account is in good standing
- A copy of their Alberta Certificate of Recognition (COR).
