Question 2: We have a request if it is possible to receive an allowance for the FSR from Rexroth (who is based in Ontario)?

Answer 2: An Allowance of \$20,000.00 will be granted. Prices will be adjusted up or down with 1379 process with appropriate invoice documentation being supplied.
