This Amendment **002** of **RFP #5000068153** is issued to: answer bidder questions.

# **QUESTION 1:**

- 1. Regarding M2: "The Bidder must demonstrate experience in managing at least three helicopter-supported geochemical sampling surveys in northern Canada that includes at least one (1) helicopter-supported lake sediment geochemical survey between January 1, 2017, to the date of bid closing."
  - a. Can NRCan please clarify the definition of helicopter-supported lake sediment geochemical survey? Does this require previous experience sampling lake sediment from a helicopter?
  - b. We have accessed sites by helicopter and then collected sediment samples from lakes (e.g. using a boat).

## ANSWER 1:

- a. For the purposes of this RFP, a helicopter-supported lake sediment geochemical survey is defined as a systematic survey of sediments from lakes within a defined area using a helicopter on floats that lands on each lake to be sampled. Samples are collected from a platform on the side of the helicopter. The aim of this qualification is to determine that the bidder can manage the rapid collection of a large number of samples to Geological Survey of Canada standards in a safe and efficient manner.
- b. This would qualify as helicopter-supported geochemical sampling survey.

## **QUESTION 2:**

2. There appears to be some differences between M2 (pg 59 of RFP): "The Bidder must demonstrate experience in managing at least three helicopter-supported geochemical sampling surveys in northern Canada that includes at least one (1) helicopter-supported lake sediment geochemical survey between January 1, 2017, to the date of bid closing." and R2 Work Experience (M2): "Bidders must include three project summaries, including at least one helicopter-supported lake sediment or lake sediment and water survey, carried out between January 1, 2017, to the date of bid closing."

Is NRCan requiring for M2 that the Bidder has experience with three projects where the sites were accessed by helicopter or one project where the site was accessed by helicopter and the other two sites can be accessed by a different means of transportation (e.g. by twin otter)?

## ANSWER 2:

NRCan requires that the Bidder has experience with three projects where the sites were accessed by helicopter. One of these projects must be a lake sediment survey, the other two could be streams, soils, tills, vegetation, etc.).
