QUESTIONS AND ANSWERS

Question 27:

Re: Section 7.11 a), (i), A. Basis of Payment, Professional Services provided under a Task Authorization with a Maximum Price: For professional services requested by Canada, in accordance with a validly issued Task Authorization, Canada will pay the Contractor, in arrears, up to the Maximum Price for the TA, for actual time worked and any resulting deliverables in accordance with the firm all-inclusive per diem rates set out in Annex B, Basis of Payment, Applicable Taxes extra. Partial days **will be prorated based on actual hours worked based on a 7.5-hour workday.**

Can Canada confirm if the highlighted area restricts Bidders to billing to a maximum 7.5 hour day, or does this allow Bidders to bill, as an example, 8 hours – “**based on actual hours worked**”?

Answer 27: The bolded text in the bidder's question does not restrict the Contractor to bill to a maximum 7.5 hour day. If a resource worked 8 hours in a given day, then the Contractor would bill for the actual time worked (8 hours).
