The purpose of Amendment 001 is to answer questions received.

1. Questions and Answers

The following questions were asked and the answers are included herein:

Question		Response
Q1	How many shipment (per year) are you expecting for each location? Do you plan on one purchase per year or several? This is important to know to determine the shipping costs to each location per year.	Both agencies (Correctional Service Canada and Parks Canada) will be placing one order each per fiscal year. The Bidder may send multiple shipments or send one. Deliveries must be on site prior to fiscal year end.
Q2	Please confirm that each agency (Corrections and Parks Canada) would be responsible for all cost of shipping us the used sights for destruction.	Yes, both agencies will ship the used sites to the Bidders location as long as it is within Canada.
Q3	Please confirm if we can hold all old night vision modules until end of term of the contract and then have destroyed at one time or must they be destroyed on reception of each return. This would possibly save considerable costs.	Yes, the Bidder may hold the used sites in storage until the completion of the contract. The Bidder accepts all responsibility for the storage of the used sights until their final disposal.
