Q#1: Reference to addendum 15 related to the SSSI clarifications

G 2.13 Single System Supplier and Integrator (SSSI)

The Contractor must provide the services of a qualified, Single System Supplier and Integrator (SSSI), who must be responsible for the coordination and integration of all of the systems within the SOWs listed herein.

The SSSI must work with the defined FSRs in each SOW to ensure complete integration of the systems.

Unless otherwise specified in the individual SOWs, the SSSI must arrange for the design, supply, and integration related components and equipment. The SSSI must work with each of the defined FSRs to determine what – if any – systems they require integration with. The SSSI must be responsible for ensuring the coordination and integration of the requirements as defined in the following SOW items:

- a) 10.12 – Emergency Generator;
- b) 12.4 – Main Engine Jacket Water;
- c) 12.23 – Dock and Sea Trials;
- d) 13.1 – Ship Service Generators;
- e) 14.2 – Motor Control Centers;
- f) 14.6 – Switchboards;
- g) 14.11 – Electrical Studies;
- h) 14.13 – Shore Power System;
- i) 15.2 – Oily Water Separator
- j) 15.5 – Fuel Oil Purifiers;
- k) 15.7 – Aft Sea Bay Recirculation;
- l) 16.1 – HVAC
- m) 16.6 – Sewage Treatment Plant
- n) 16.12 – Boilers
- o) 17.1 – Stores Crane
- p) 18.1 – Shipboard Integrated Communications System
- q) 19.1 – Propulsion Control System;
- r) 19.2 – Bow Thruster Control; and
- s) 19.3 – Alarm and Monitoring System.

FSR have already been pre-choosen for many of the items, so is the SSSI responsible for the FSR supply of equipment? What are the responsibilities you are looking from the SSSI ?

A#1:

The Single System Supplier and Integrator (SSSI) will only get involved with the SOW items listed in Paras. G.2.13 (a – s) that require to be integrated with existing systems onboard the CCGS Griffon. Integration doesn't solely mean electrical but this might also mean mechanical, Electronic etc.. unless otherwise stated in the SOW items listed in Paras. G.2.13 (a – s). The SSSI must be responsible for the supply of all non-FSR materials necessary to install and integrate the equipment mentioned in each individual SOW item.

Example: We are not expecting the SSSI to supply the Sewage Treatment plant but if this system needs to be connected to the main alarm and monitoring system, we are expecting the SSSI to supply all the components required for that Integration.
