The purpose of Amendment 003 is to extend the closing date of the Invitation to Qualify.

Question 1:

1. Requests to Extend Closing Date

- a. The subject ITQ, page 1, communicates a solicitation closing date of 2024 – 01 -05. The release of the ITQ occurred 7 Dec 23, giving industry 29 days to respond which would normally be a reasonable period of time to coalesce a compliant response. However, the response period includes the Christmas and New Year’s celebrations where many people within our company and those of our partnered companies have planned time away from work. Our ability to provide a compliant submission would require the disruption of people’s intended time with their families and it is made significantly more challenging as some of our partners are not available to provide critical information that is needed for our response. An extension to the solicitation date would alleviate the challenges posed by the Holiday period and therefore we respectfully request a 30-day extension to the published closing date.
- b. The individuals we need in order to properly respond to this will be away for the holidays until January 2. This will not give us enough time to respond thoroughly. We are requesting a 2 week extension.

Response 1:

Canada has considered the requests and will extend the solicitation period for the Invitation to Qualify by 14 days. The new closing date is 2:00 PM EST on 19 January 2024.
