001	Is there a process post qualification, to support changing the qualified prime entity from within the respondent team, assuming it is another member of the prime group (ie. A fully owned subsidiary or parent company). As the procurement progresses, depending on requirements evolvement, It may be necessary to bid from another entity within the Corporate group. In order to avoid qualifying each entity within the Corporate group at this stage, we would like to confirm that there is a process for changing the prime entity (from within the respondent team) in later stages.	Changing the name of the prime entity post qualification will be addressed on a case-by-case basis. Changes of just a name or division but still under the umbrella of the parent company will be accepted.
