This amendment (005) is issued to address a question regarding M6 for both individuals and businesses

Question 1:

Regarding M6 for both individuals and businesses, the respective details for destruction requirements, Table M6.1 and M6.2 are the same.

However, M6 for individuals stipulates the requirement for client references. Given the sensitive nature of this program, individual client references may prove difficult to obtain. Would Canada consider standardizing M6 for individuals to match that of the business requirement to satisfy both businesses and individuals?

Response 1:

Canada has decided to standardize the submission requirements for both M6 – Businesses and M6 – Individuals.
