Q90. Will the product demonstrations be at the EY Centre during the CANSEC event or off-site?

A90. Suppliers have the option to conduct the product demonstrations at their designated area at the EY Centre during the CANSEC event or off-site at a DND facility within the National Capital Area. The DND facility will be determined based on the availability and number of Supplier interest.

Please be advised that Canada will not reimburse any respondent for expenses incurred in responding to this RFI, as per RFI Part 2, 2.2 Response Costs. Suppliers are responsible for all costs related to the RFI industry engagement activities, including but not limited to, One-on-one session (e.g. Product Demonstrations).

Q91. Will Canada allow for virtual product demonstrations via MS Teams, during the 3rd One-on-one Sessions: Product Demonstrations?

Q92. Would Canada consider Product Demonstrations at the Supplier's on-site facility?

A92. Canada will not be able to participate in on-site tour, product demonstrations or presentations at potential Suppliers' facility(ies).

Q93. Would Canada be able to meet with Suppliers to discuss their products?

A93. All industry engagement activities, past and future, are outlined in the RFI, including industry days, one-on-one sessions and/or working group meetings. Canada will not accept any requests for meetings, presentations, unless otherwise stated in the RFI and/or RFI Amendments.
