1. Questions and answers

Question 18. Can GAC confirm that all bidders are to submit their financial proposals based on the minimum level of effort prescribed in the RFP document? That is 240 days per year for each of the three rated positions.

Answer 18. Yes, bidders must submit their financial proposals based on the “Firm Daily Rates” established in Annex B – Basis of payment for each consecutive year (1 – 5).

Question 19. Can GAC confirm the maximum allowable budget for the project?

Answer 19. To encourage competition, a maximum allowable budget has not been identified for the following solicitation.

Question 20. Will GAC consider a 2-week extension to the bid deadline?

Answer 20. Canada will extend the closing date of the RFP by an additional week.
