2. In the case of an identical resource or identical resources proposed by more than one bidder

Following validation of the consent or proof of employment, if the successful bidder's proposed resource withdraws or becomes unable to provide the services before the contract award, the resource will no longer be considered from any other bidder who offered that same resource for the performance of the contract.

3. Replacement of a resource prior to contract award

If the successful bidder's proposed resource recommended for the contract award withdraws and/or becomes unable to provide its services for the performance of the contract, at any time between the closing date and time of the RFP and the award of the contract, the bidder must immediately inform the contracting authority of the reason for the replacement.

The bidder must propose, at the same hourly rate indicated in its bid, one replacement who must meet all of the mandatory requirements contained in the RFP and, if applicable, obtains an equal or higher score obtained by the originally proposed resource on the point rated criteria of the RFP. Upon request by the contracting authority and within the time allowed (minimum of one business day), the bidder must provide the necessary information to allow assessment of the replacement, including but not limited to, its name, qualifications and experience. Failure to respond to the request will result in the bid being declared non-responsive.

4. Bid challenge and recourse mechanisms

Several mechanisms are available to potential suppliers to challenge aspects of the procurement process up to and including contract award.

4.1 Use of individual protective equipment and Occupational Health and Safety (OHS) guideline(s)

The Contractor warrants that its resources will follow at all times the OHS guidelines in force in the workplace during the contract period. Canada reserves the right to modify the OHS guideline, if required, to include any future recommendations proposed by the Public Health Agencies.

5.0 Term of contract

5.1 Period of contract

5.2 Maximum duration of contracts

A contract awarded under the THS for the NCR supply arrangement must not exceeds 48 consecutive weeks including all absences.

On an exceptional basis only, a contract may be amended to extend the duration of an assignment period up to a maximum of 24 consecutive weeks beyond the limit of 48 consecutive weeks (example total extended duration must not exceed 72 consecutive weeks) on the condition that the following requirements are met:

- i. the duration of the assignment period, including any contract amendments that impact the assignment period, must be more than 40 consecutive weeks;
- ii. the amendment to extend the duration of the assignment period must be issued after the first 40 consecutive weeks of the assignment period; and
- iii. the contracting authority must notify THS for the NCR of the issued amendment by email within 2 business days of issuing the amendment.

The contractor agrees that, during the extended periods of the contract, it will be paid in accordance with the applicable provisions as set out in Annex B: Basis of payment.

6.0 Authorities

6.1 Contracting authority

The contracting authority for the contract is:

The contracting authority is responsible for the management of the contract and any changes to the contract must be authorized in writing by the contracting authority. 7.0 Proactive disclosure of contracts with former public servants

8.0 Payment

8.1 Basis of payment

The contractor will be paid for the actual hours worked at the firm hourly rates in Annex B: Basis of payment. The contractor will be paid an initial half hour minimum charge calculated from the time the contractor's employee arrives on-site. Customs duties are included and applicable taxes are extra.

8.1.1 Travel and living expenses

Canada will not accept any travel and living expenses incurred by the contractor in the performance of the work, for:

8.2 Method of payment

Canada will pay the contractor on a monthly basis for work performed during the month covered by the invoice in accordance with the payment provisions of the contract if:

- an accurate and complete invoice and any other documents required by the contract have been submitted in accordance with the invoicing instructions provided at 8.2.1 below;
- all such documents have been verified by Canada;
- the work performed has been accepted by Canada.

8.2.1 Invoices

9.0 Certifications compliance

Unless specified otherwise, the continuous compliance with the certifications provided by the contractor in its bid or precedent to contract award, and the ongoing cooperation in providing additional information are conditions of the contract and failure to comply will constitute the contractor in default. Certifications are subject to verification by Canada during the entire period of the contract.

9.1 Compliance with on-site measures, standing orders, policies, and rules

10.0 Applicable laws

12.0 Discretionary audit - non-commercial goods and/or services

The estimated amount of profit included in the contractor's price or rate certification is subject to audit by Canada, before or after payment is made to the contractor under the conditions of the contract. The purpose of the audit would be to determine whether the actual profit earned on a single contract if only one exists, or the aggregate of actual profit earned by the contractor on a series of negotiated firm price and fixed-time rate contracts performed during a particular period selected, is reasonable and justifiable based on the estimated amount of profit included in earlier price or rate certification(s).

If the audit demonstrates that the actual profit is not reasonable and justifiable, as defined above, the contractor must repay Canada the amount found to be in excess.

13.0 Foreign nationals (Canadian contractor)

The contractor must comply with Canadian immigration requirements applicable to foreign nationals entering Canada to work temporarily in fulfillment of the contract. ANNEX A - Statement of work

1. Scope

The Defense Service Operations Centre (DEFSOC) Knowledge Management cell is in need of additional resource to manage our onboard process to D365 which will provide information to a wider audience as well as provide business continuity plan.

This Statement of Work (SOW) highlights the requirement for a SharePoint Online, Power BI and Office 365 Subject Matter Expert (SME) to enable DEFSOC to develop an Enterprise wide Information Technology Service Management (ITSM) based Knowledge Management System.

1.1. Objective

To obtain Human Resource needed to fill the gap in Knowledge Management section of IT Service Operations for DEFSOC to maintain the operational effectiveness of the National Service Desk, DEFSOC Service Operations, DND/CAF established IT Service Management Centers (SMCs) and Service Support lines, both internal and external to DND/CAF.

The resources will help achieve the objective of developing enterprise-wide Playbook that will be referenced by all users as well as DND/CAF Stakeholders.

1.2. Background

The Defense Service Operation Centre (DEFSOC) mission is to coordinate in-service support for Joint Communications Information Systems across DND/CAF operations and activities, through established documentation in support of network operations processes and procedures.

The DEFSOC Knowledge Management System (DKMS) Playbook is one of the main tools used by DND National Service Desk and Service Operations staff. It is also widely accessed SMCs, Stakeholders, regular users and information requests from Other Departmental Organizations, hence needs constant maintenance.

The Playbook publication includes procedures, tips and fixes, knowledge base to workarounds to known issues, guidelines, points of contact on various systems, domains, services and networks across the DND/CAF information technologies, information management and cyber domains.

2. Requirement

2.1. Scope of work

- Developing and maintaining DEFSOC Knowledge Management System (DKMS)
 which requires technical knowledge and experience to administer and manage the
 service.
- Continuous Improvement of the DEFSOC Service Operations processes in line with ITSM model of governance by frequent consultations, research, gathering, investigating, review of information received and analyzing information with the aim of improving accessibility and reliability knowledge content for the end user.
- Understanding DEFSOC DND networks, systems and services, which includes concepts, process, tools, foundations, methodologies and KM best practices.

2.2. Tasks

Developing and maintaining current DKMS and new Enterprise Content Management system.

- Design and develop solutions using cloud-based applications like Power BI and SharePoint Online.
- o SharePoint online administration and publishing.
- Develop a new and interactive Templates, Forms, Table of Contents, Index, Glossary items.

Continuous Improvement of DND Information Technology Service Operations.

- Regular review and update of published documentation, according to set standards both the Unclassified and Classified Playbook, and make it available on D365 (Azure Tenant)
- Development of SMC Playbooks both on Internal Networks and D365

2.3. Constraints

- DEFSOC is a high paced environment with tight deadlines and a lot of changing priorities, there will be occasions when resource will be working under pressure.
- The candidate's main place of work will be the NDHQ, 101 Colonel By. Drive, Ottawa working on classified networks. Onsite presence is required.
