Response(s) (R) to Question(s) (Q):

Q1: Re. CAT 1B item A, Will the CA also accept a PET-Felt privacy screen?

R1: No the privacy screen needs to meet the SOW description.

Q2: Re. CAT 1B item A,Is this screen to be exactly 48"W or match the nominal height adjustable table CAT2 Item D width of 46"?

R2: 46" wide is acceptable.

Q3: Re. CAT 2 items D-G, Additional notes have the height adjustable surfaces as exact sizes, please advise if this is correct as they will not have any pinch point allowances, or will the CA accept nominal sizes per the SA i.e. 2" on width and 1" on depth to allow for pinch points and wire drops

R3: Nominal sizes are acceptable.

Q4: Re. CAT 1B item C, Network outlet connectors and hinged cable management systems that run along the base of the table do not form part of the SA and these specifications may be manufacture-specific. These components also will not work with the required minimum height of modesty on these desks that must sit above the floor. Please respectfully remove these requirements and utilize supplier-standard cable management that meets the SA requirements.

R4: Work surfaces must have at least one gutter below the surface to allow electrical and network cables to pass through. For fixed surfaces, it is not mandatory to have the cable management system articulated and flexible along the base, but the cable management gutter under the surface is mandatory.

Q5: Re. CAT 1B item C, A six-power outlet bar does not form part of the SA requirements for this GoCUID, if the CA requires this please respectfully add it as a non-SA item or procure it separately.

R5: We'll change it to non-SA. Power bar must be included in the quote.

Q6: Re. CAT 2 items D-G., The requirement for a cable management system that shall allow for the electrification of all workstations is not a requirement of the SA for freestanding height adjustable tables. Under these GoCUID each table per the SA will have its own cable management and dedicated power cord. What is being described is a shared hardwired feed in a benching application. Further, the required network outlet connectors and hinged cable management systems that run along the base of the table do not form part of the SA and these specifications may be manufacture-specific. Please respectfully remove these requirements.

R6: According to SA, all height-adjustable tables are equipped with a vertical cable routing system. We maintain the same requirements so that every workstation can be electrified and wired.

Q7: Re. CAT 2 items D-G., A six-power outlet bar does not form part of the SA requirements for this GoCUID, if the CA requires this please respectfully add it as a non-SA item or procure it separately.

R7: We'll change it to non-SA. Power bar must be included in the quote.

Q8: Category 1b, Item C, 1bFFHRED24L72WNOLNY, The cable management requirements as noted on page 11 fall outside the SA requirements for these worksurfaces (3.2.1. Category 1b, Freestanding worksurfaces, fixed height worksurfaces). Can you please move this item to NSA.

R8: Work surfaces must have at least one gutter below the surface to allow the passage of electrical and network cables. For fixed surfaces, a flexible, articulated cable management system along the base is not mandatory, but the cable management gutter under the surface is.

Q9: Category 1b, Item C, 1bFFHRED24L72WNOLNY, Can you please clarify what is meant by Network outlet connector? Is this a box/opening to house a data faceplate (provided by others)?

R9: It is a box/opening to house a data faceplate (provided by others).

Q10: Category 1b, Item C, 1bFFHRED24L72WNOLNY, Can you please clarify what is meant by Hinged and flexible cable management along the base? Is this located under the surface, or is the requirement for vertical wire management? **R10:** The cable gutter must be below the surfaces.

Q11: Does the client require power outlets to be accessible from the top of the worksurface by way of a recessed power module? Or will grommets suffice for wires to pass thru to below?

R11: Power sockets (power bar of 6 sockets) must be below the surface and not accessible. A CAT 5 socket module is required for sockets on work surfaces. Grommets are used to pass cables for workstation equipment.

Q12: Will the power supply be hardwired for these worksurfaces? Or will the power be supplied from a plug from the wall? **R12:** From a plug from the wall.

Q13: Category 2, Items D-G, can you please clarify what is meant by Network outlet connector? Is this a box/opening to house a data faceplate (provided by others)?

R13: It is a box/opening to house a data faceplate (provided by others).

Design Upgrade Rule:

The IU may exercise an option to upgrade products up to 20% of each Category product total before Applicable Taxes after contract award.

The Design Upgrade amount is used at the discretion of the Project Authority (PA) **prior to the manufacturing/ordering of the products**, the PA will provide the Contractor with a written notice of Canada's Design Upgrade choices for each of the product(s) to be upgraded. 

A - Privacy Panels

Privacy panels must be attached to tables. Panels must be 48 inches long and a minimum of 28 inches high. The portion of the panels above the table must be at least 20 inches high.

Panels must be made of fabric. Fabric must have moisture, stain and odor resistant properties.

Upholstery seams must be straight and aligned with the frame. Upholstery or mesh fabric must have no wrinkling or stretching.

They must be constructed with a rigid wood, metal or plywood frame and finished according to the requirements detailed in the SA.

B - Pedestals

The pedestals must be lockable with keys. Two (2) keys per pedestal must be provided. Locks shall be unique and a master key most be provided to the departmental representative upon installation.

Pedestals shall have a padded fabric cushion on top.

Pedestals must have casters.

Pedestals must have two (2) drawers. Both drawers shall be locked simultaneously with the same key. The height of the pedestals, including casters and cushion, must not exceed 27 inches.

C - Fixed Height Work Surfaces

The surfaces must be in laminate. The base of the surface shall be 2 sides full height.

The shape of the tables is rectangular

The tables size is 24x72, 29 inches high.

Cables management

A cable management system shall be included. Cables most be concealed and shall allow for the electrification of all workstations.

For all tables, the supplier shall provide and install a cable management system that most include the following items:

- 6 outlet power bar attached under each table
- Network outlet connectors (2 network outlets for each 30" deep table)
- Cable management gutter under the surface
- Hinged and flexible cable management system along the base

Work surfaces and tables should have cable management accessories such as grommets. The grommets should be at the bottom of the surface.
