1.0 Questions and Answers

Question 4: REQUIREMENTS

Hotel Accommodations: CBSA will require single and/or double occupancy One Bedrooms Suite at a minimum rating of three (3) Diamonds from the AAA/CAA Diamond-Rating Program AAA/CAA Diamond-Rating Program (amatravel.ca).

Question: Apart from the AAA/CAA Diamond Rating, do you accept any 3-star hotel that has a minimum 4-star (Excellent/Very Good) review as per Expedia(hotels.com) or Booking.com or TripAdvisor from the guests who stayed earlier, in terms of their Property conditions and facilities, Staff, and Service, cleanliness, comfort, and amenities?

Answer 4: No, we have defined the specific criteria so the tool against which all hotels are being rated is standard.

Question 5: Rooms must include: vii) Be equipped with a kitchenette which includes at minimum a: microwave, sink, refrigerator, coffee machine and identify if a cooktop stove is available.

Question: Do you accept any hotel with all the above amenities except a cooktop?

Answer 5: Yes, the room must have a kitchenette which includes at minimum a: microwave, sink, refrigerator, and coffee machine. If a cooktop is available this should be identified.

Question 6: Can you please clarify what is meant by the wording in Mandatory Requirement number seven (7) “.... and identify if a cook top stove is available.”

Question: Are you asking for a kitchenette in the room with a built-in stove top. Or can we simply put a hot plate in the room and plug it into a wall?

Answer 6: If there is a cook top stove available please identify. At this time if you can equip each room with a hot plate cooktop this can be identified.
