2. Clarify the close date of the Request for Bid.

QUESTIONS AND ANSWERS:

Question 1	Would a laminate panel base that matches the surfaces or box be accepted for the panels?
Answer 1	.No, panels to be metal with fabric elements

Question 2	We can include up to 2 duplexes and 1 data per panel, is this enough for panels requiring electrical outlets?
Answer 2	Yes

Question 3	We don't have a 72" wide panel, can we replace with 2 36" wide panels?
Answer 3	For P-6, we prefer having a 30" wide panel + a 42" wide panel to align the first panel (30" wide) and leg to the end of the height adjustable table. This also provide move leg room on the return surface.

Question 4	Are grommets required on adjustable tables?
Answer 4	No

Question 5	Do we need to add wiring management below the surface and also down to the floor for adjustable tables?
Answer 5	Yes, please add a wire management (cable tray) under the surface + a wire management for wires going down to the bottom of the panels.

Question 6	Are double-height screens (serving as a modesty and privacy screen at the bottom and top of the surface) of felt accepted for the SU13.
Answer 6	Yes, we accept a double-height screens (serving as a modesty and privacy screen at the bottom and top of the surface) of felt for SU-13 AND SU-14 as long as it covers the same dimensions under the desk as a standard modesty panel would.

Question 7	Would WR-1 and WR-2 be accepted at 18" wide?
Answer 7	Yes, we accept W-1 and W-2 to be 18" wide

Question 8	The CR-1 is indeed a 42" wide splashback with 2 full-width die drawers?
Answer 8	I am not familiar with the splashback term. If this refers to a credenza unit, yes. CR-1 to be a credenza unit in laminate with 2 full width (File/File) drawers, total dimensions of 42" wide x 24" deep, keyed, bar pull handles + laminate top surface if it comes separately.

Question 9	Can we get an extension (1 more week)? Given the amount of bid opportunities that are currently open, we are asking for an extension so we can properly work on this large opportunity.
Answer 9	We accept an extension of 3 days.

Question 10	Will you accept for Panel P-6 a 30"W + 42"W panel instead of the 72"W panel?

Answer 10	Yes, we accept Panel P-6 to be a 30"W + 42"W panel if there is no 72" wide panel available.
