Item 1:

QUESTION 1:

On page 46. Item 6 Language of the RFP, RCMP notes that “For the purposes of evaluating most of the resources proposed as part of this RFP, the minimum language requirement will be English Only. However, additional points will be provided in the rated evaluation for bilingual resources.”

However, there is no wording in the rated evaluation that identifies how many additional points can be scored for bilingual resources.

Can RCMP please provide clarification for how RCMP will award points for bilingual resources?

RESPONSE 1:

No points will be provided for a Bilingual Resources, however during the period of the contract specific TA’s may require a bilingual resource as a part of the requirement.

QUESTION 2:

On page 16 in the Mandatory Technical Criteria table, criteria M-SID-2, M-IID-2 and M-JID-2 all state that the proposed Interior Designer resources must have a minimum...providing **move coordination** services. We are assuming this was a cut and paste error.

Can RCMP please confirm and issue a correction, if necessary?

RESPONSE 2:

Yes, this is a cut and paste error. An amendment for all three criteria M-SID-2, M-IID-2 and M-JID-2 will be issued.



QUESTION 3:

On page 22 in the Rated Technical Criteria table, criteria R-PFM-1 and R-PFM-2 are the exact same. We are assuming this was a cut and paste error. Can RCMP please confirm and issue a correction to the table?

RESPONSE 3:

Yes, another copy and paste error. A correction to the wording for the criteria R-PFM-1 in the Rated Technical Criteria table will be issued via an amendment.
