PART 1 - GENERAL INFORMATION

1.1 Security Requirements

There is no security requirement associated with this bid solicitation.

1.2 Statement of Work

The requirement is detailed in Annex "B" - Multi-Caliber Weapon System Bipod System.

1.3 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1.4 Trade Agreements

The requirement is subject to the provisions of the Canadian Free Trade Agreement (CFTA).

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the Standard Acquisition Clauses and Conditions Manual (https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

2.2 Electronic Submission of Bids

a) Bids must be submitted only to the Department of National Defence by the date, time and place indicated on page 1 of the bid solicitation. Bids must be received electronically as noted in subparagraph b). b) Electronic Submissions: Individual e-mails exceeding five (5) megabytes, or that includes other factors such as embedded macros and/or links, may be rejected by the DND e-mail system and/or firewall(s) without notice to the Bidder or Contracting Authority. Larger bids may be submitted through more than one e-mail. The Contracting Authority will confirm receipt of documents. It is the Bidder's responsibility to ensure that the Contracting Authority has received the entire submission. Bidders should not assume that all documents have been received unless the Contracting Authority confirms receipt of each document. In order to minimize the potential for technical issues, Bidders are requested to allow sufficient time before the closing time and date to confirm receipt. Technical and financial documents received after the closing time and date will not be accepted.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than 10 calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario, Canada

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

Bidders may use Attachment 1 to Part 3 Financial Bid to indicate their prices. If Bidders choose to use Attachment 1 to Part 3 Financial Bid to indicate their prices, Bidders must include Attachment 1 to Part 3 Financial Bid in their financial bid.

Section I: Technical Bid

In their technical bid, Bidders should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work.

Bidders must submit a shipping document in PDF format by e-mail to the Contracting Authority indicating the date that the pre-award samples were shipped out to the address at Para 4.1.1.2. The pre-award samples must be received before the solicitation deadline.

Section II: Financial Bid

Bidders must submit their financial bid as follows:

Bidders must submit firm prices, Delivered Duty Paid (DDP) at 25 CFSD Montreal. Incoterms 2010, Applicable Taxes excluded. The total amount of Applicable Taxes must be shown separately.

Bids must be submitted in Canadian dollars.

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

4.1 Evaluation Procedures

- a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- b) An evaluation team composed of representatives of Canada will evaluate the bids.

4.1.1 Technical Evaluation

4.1.1.1 Mandatory Technical Criteria

4.1.1.2 Pre-Award Sample(s) and Supporting Documentation

As part of the technical evaluation, to confirm a Bidder's capability of meeting the technical requirements, three (3) pre-award Bipod System samples (each containing one (1) bipod, a pair of spike feet, a pair of claw/ski feet, a pair of rubber feet and a pair of leg extensions), test results and manufacturer's technical data sheets as per Annex "B"– Multi Caliber Weapon System Bipod System Technical Purchase Description must be submitted at time of bid closing at no charge to Canada.

The Bidder must ensure that the following information is clearly printed or typed on all pre-award samples or on its packaging:

The test reports and manufacturer's technical data sheets must be sent electronically with the bid.

Failure to submit the required pre-award samples and supporting documentation within the specified time frame will result in the bid being declared non-responsive. The samples submitted by the Bidder will remain the property of Canada.

The Bidder must ensure that the required pre-award samples are manufactured in accordance with the technical requirement and are fully representative of the bid submitted. Rejection of the pre-award samples will result in the bid being declared non-responsive.

4.1.2 Financial Evaluation

The price of the bid will be evaluated in Canadian dollars, Delivered Duty Paid (DDP) at 25 CFSD Montreal Quebec, Incoterms 2010, Canadian customs duties and excise taxes included, Applicable Taxes excluded.

4.2 Basis of Selection

A bid must comply with the requirements of the bid solicitation and meet all mandatory technical evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated aggregate price will be recommended for award of a contract.

PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Unless otherwise specified, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

5.1 Certifications Required with the Bid

Bidders must submit the following duly completed certifications as part of their bid.

1 INTRODUCTION

1.1 Scope

- 1.1.1 The sniper is required to accurately engage targets out to 1,200 m with the Multi-Caliber Sniper Weapon (MCWS) by day and night under extreme weather conditions. The sniper is often required to take difficult shots at stationary and moving targets of opportunity with fast engagement times. A dependable, precise, and easily adjustable MCWS Bipod System will provide the sniper with a stable shooting platform to ensure that the sniper is successful meeting his mission objectives.
- 1.1.2 This specification details the mandatory requirements to be met by the MCWS Bipod System.

3 REQUIREMENTS

3.1 Physical Requirements

- 3.1.1 The MCWS Bipod System must be delivered with all components necessary to allow the sniper to attach the MCWS Bipod to the 6 O'clock NATO Accessory Rail on the C21 MCWS which is manufactured in accordance with STANAG 4694.
- 3.1.2 The MCWS Bipod interface to the NATO Accessory Rail must be secure and remain secure during the continuous firing of the C21 MCWS when configured to shoot .338 caliber Lapua Magnum (LM) ammunition.
- 3.1.3 The MCWS Bipod interface to the NATO Accessory Rail must have one or more recoil lug (s) which reduces movement between the interface mechanism and the NATO accessory rail.
- 3.1.4 The MCWS Bipod must be installed and removed by hand without the use of tools.
- 3.1.5 The MCWS Bipod must be removable from the NATO Accessory Rail as a single component including the rail interface via a quick detach locking lever(s).
- 3.1.6 The MCWS Bipod ground clearance to the 6 O'clock NATO Accessory Rail must be equal to or less than 178 mm (7.0 in) when the bi-pod legs are fully collapsed and stowed in the 90° position.
- 3.1.7 The MCWS Bipod ground clearance to the 6 O'clock NATO Accessory Rail must be equal to or greater than 210 mm (8.25 in) but no greater than 254 mm (10.0 inches) when the bipod legs are fully extended and stowed in the 90° position.
- 3.1.8 The MCWS Bipod ground footprint must be equal to or less than 368 mm (14.5 inches) when the bipod legs are fully extended and stowed in the 90° position.
- 3.1.9 The MCWS Bipod must have a 180° range of motion front to back and be lockable in at least five (5) positions spread evenly throughout the range of motion (ie located at 0°, 45°, 90°, 135° and 180° or 0°, 30°, 60°, 90°, 120°,150° and 180°).
- 3.1.10 The MCWS Bipod must be stable when locked in all positions.
- 3.1.11 The MCWS Bipod legs must not bend under the loads of weapon firing and the loading of the sniper's body weight onto the MCWS Bipod as the sniper takes aim and tightens weapon stance.
- 3.1.12 The MCWS Bipod legs must not rotate preventing the walking of the C21 MCWS when firing.
- 3.1.13 Each MCWS Bipod leg must adjust for length using one hand and lock in 4 or more positions.
- 3.1.14 The sniper must transition between MCWS Bipod leg positions in under 5 seconds.
- 3.1.15 The MCWS Bipod must adjust for cant.
- 3.1.16 The MCWS Bipod cant must be around a single pivot point.
- 3.1.17 The MCWS Bipod must lock in any desired cant position.
- 3.1.18 When the MCWS Bipod is locked in a cant position it must hold that position under weapon fire or shifting of the sniper on the weapon.
- 3.1.19 The MCWS Bipod must cant at least 15° to the left and 15° to the right of the center position for a total minimum cant of 30°.
- 3.1.20 The MCWS Bipod must not adjust for pan.
- 3.1.21 The MCWS Bipod including rail interface attachments and rubber feet must weigh less than or equal to 635 grams (22.4 ounces).
- 3.1.22 The MCWS Bipod colour must black.

- 3.1.23 The feet of the MCWS Bipod must be made of rubber or similar material that prevents movement and reduces shock from weapon fire.
- 3.1.24 The feet of the MCWS Bipod must be removable and replaceable by the sniper.
- 3.1.25 The MCWS Bipod must be manufactured from 6061-T6 aluminum, or an alternative material approved by the TA.
- 3.1.26 The MCWS Bipod metal components must be hard coat anodized IAW MIL-A-8625 Type III Class 2.
- 3.1.27 The MCWS Bipod must not require operator maintenance beyond cleaning and lubrication.
- 3.1.28 The MCWS Bipod must function in climatic environments C2 Cold (-46 deg C) and A1 Hot Dry (+ 49 deg C) IAW Mil-Std 810G.

3.2 Alternate Feet & Pouch

- 3.2.1 The MCWS Bipod must be delivered with replaceable feet for use on ice (often referred to as spike feet).
- 3.2.2 The MCWS Bipod must be delivered with replaceable feet for use in dirt/mud (often referred to as claw or ski feet).
- 3.2.3 The MCWS Bipod must be delivered with a set of leg extensions that extent the leg length by a minimum of 508 mm (2.0 inches).
- 3.2.4 The MCWS Bipod, replaceable feet (spike and claw or ski) and leg extensions must be delivered in a zippered pouch made using 330 denier or heavier Cordura Class 2 or Class 3 fabric that is black or tan in colour IAW Mil-DTL-32439A.

3 **Part 1 Technical Bid Evaluation Plan**

3.1 Outline

- 3.1.1 The MCWS bipod system technical evaluation of bids will be conducted in phases with a bidder's overall compliance being determined at the end of each phase.
- 3.1.2 The evaluation phases are summarized as follows:

3.2 **Phase 1 Technical Evaluation**

3.2.1 Phase 1 will be a physical examination of bid samples and the mandatory technical/ documentary evidence provided by bidders. Only those bids deemed to be technically compliant will the Phase 1 Technical Evaluation will progress to Phase 2 User Trial. Non-compliant bids will not be considered further.

3.3 Phase 2 User Trial

- 3.3.1 Phase 2 will be a User Trial where military personnel will be required to use the bid samples in field conditions to assess their in-use performance and then score them against pre-determined criteria and scoring scheme.
- 3.3.2 To be compliant with Phase 2 a bidder must achieve a Final Point Score (FPS) of 68 points or higher out of a total possible 84 points.

4 Evaluation Criteria

4.1 **Phase 1 Mandatory Criteria**

4.1.1 Mandatory criteria are identified in the Technical Evaluation Workbook attached as Appendix 1 to Annex C. Failure to meet these criteria will render the bid non-compliant and it will be removed from further consideration.

4.2 Phase 2 User Trial

4.2.1 Point rated criteria with minimum mandatory score requirement is identified in Section 6 to Annex C.

5 **Phase 1 Mandatory Criteria Evaluation**

5.1 **Proposal Documentation**

5.1.1 The bidder's proposal should include a signed and dated copy of the Technical Evaluation Workbook (Appendix 1 to Annex C), with the self-assessment at Columns 5, 6 and 7 completed, and the required documentary evidence attached as detailed in Column 4. References to external sources and web sites will not be accepted. Instruction for the completion of Columns 5, 6 and 7 and the **purpose of** information in Column 4 are below.

5.1.2 Column 4

5.1.2.1 This column describes what the bidder must submit with his proposal (samples, test reports, documentary evidence etc) to confirm compliance with the mandatory requirement.

5.1.3 Column 5 "Bidder's Self-Assessment"

5.1.3.1 This column is a bidder's self-assessment column where a bidder should indicate whether he is compliant/non-compliant to each mandatory requirement being evaluated. Each cell contains a drop-down menu with two choices. The bidder should choose either "compliant" or "non-compliant".

5.1.4 Column 6 "Evidence Location in Bid Package"

5.1.4.1 In this column the bidder should clearly identify where in the bid binder (document, page, and paragraph) the evaluator can find information that supports the bidder's compliance against the mandatory requirement.

5.1.5 Columns 7 "Bidder's Statement and/or Comments"

5.1.5.1 In this column the bidder should provide additional information that they would like to bring to the attention of the evaluator for consideration during his assessment of each of the mandatory requirements.

5.1.6 Mandatory Counter

5.1.6.1 At the top of the workbook the bidder can track his rated compliance against the total number of mandatory requirements.

6 Phase 2 User Trial

6.1 **Performance Evaluation**

6.1.1 Evaluators will trial the bidders' samples in accordance with the process described in this section.

6.2 Evaluators

6.2.1 Three qualified snipers or expert shooters will be used to conduct the performance evaluation.

6.3 Test Shoot

6.3.1 For each bid sample, each evaluator will fire 20 rounds of .338 LM (B408) ammunition using a C21 MCWS with the bipods to be evaluated. To minimize bias, the bipods will be fired in accordance with Table 1 below (assumes four compliant bipods from Phase 1).

6.4 **Evaluation Score**

6.4.1 Immediately following each shoot, the evaluators will be asked to assess the bipod used based on a standard Likert-type questionnaire (see Appendix 2 to Annex C). Each criterion will be allocated a score up to a maximum of 7 possible points per question. The total score awarded by a single evaluator to a single bipod will be the summation of the points allocated against each question for that bipod by that evaluator. The score assigned to a bipod for the purposes of determining compliance for Phase 2 will be the average of the three evaluators' scores (i.e. the sum of the three separate total scores divided by three). This average score will be known as the bidders FPS.

6.5 **Phase 2 Compliance**

- 6.5.1 To be considered compliant at Phase 2 a bid must achieve a FPS of 68 points or higher out of a total possible 84 points.
- 6.5.2 Non-compliant bids will not be considered further.

6.6 **Document Compliance**

6.6.1 The bidder must point to the documentation which confirms that their bipod meets the mandatory requirement. The documentation could be independent third-party test report, internal test reports, component/assembly drawings, QA documentation, material specifications, product specifications, marketing literature, operator /parts manuals etc. Where possible the bidder should submit more than one document to confirm compliance.

6.7 Bid Test Reports

6.7.1 All required tests must be conducted by accredited independent laboratories, or university laboratories, or government laboratories, all experienced with testing the commodity being delivered, and all within the jurisdiction of NATO member states. Testing conducted by any other entities must receive prior written approval from the TA.

6.8 Bid Samples

6.8.1 The Bidder certifies that the Bid Physical Samples are equivalent to the specimens featured in the Bid Test Reports, such that if the Bid Physical Samples (or specimens taken from them) were subjected to the same testing, the results would be consistent with those in the Bid Test Reports.
