AMENDMENT 004 TO SOLICITATION NUMBER W6369-23-A012 IS RAISED TO:

1. Update sub-section 4.2 - Basis of Selection - Lowest Price Per Point; and
2. Update Annex A -Statement of Work – sub-section 3.1.

SOLICITATION NUMBER W6369-23-A012 IS HEREBY AMENDED AS FOLLOWS:

6. **DELETE** sub-section 4.2 - Basis of Selection - Lowest Price Per Point in its entirety, and **REPLACE** with the following:

4.2 Basis of Selection - Lowest Price Per Point

- A. To be declared responsive, a bid must:

- (i) Comply with all the requirements of the bid solicitation;
- (ii) Meet all mandatory technical evaluation criteria; and
- (iii) Obtain the required minimum of 500 points overall for the technical evaluation criteria which are subject to point rating. The rating is performed on a scale of 2100 points.

- B. Bids not meeting (i) or (ii) or (iii) will be declared non-responsive. Neither the responsive bid that receives the highest number of points nor the one that proposed the lowest price will necessarily be accepted. The responsive bid with the lowest evaluated price per point will be recommended for award of a contract.

- C. Should two (2) or more responsive bids achieve an identical lowest price per point, the bid with the lowest overall price will be recommended for award of a contract.

7. **DELETE** Annex A -Statement of Work – sub-section 3.1 in its entirety, and **REPLACE** with the following:

- 3.1 DND employees, CAF members, and Cadets are required to maintain FA qualification.

ALL OTHER TERMS AND CONDITIONS REMAIN THE SAME.
