## **AMENDMENT 001**

Amendment 001 is raised to answer the following questions:

#### **QUESTION 1:**

Controlled Good program: I think this would be for prohibited firearms, parts of, prohibited ammunition, and prohibited devices. My present firearms business license authorizes me to inspect, identify and test them. Must I fill some kind of form to be put on a list? Do I have to keep a log of controlled goods I examine? This would require me to classify the firearm and would mean more work like measuring barrel length, caliber, magazine capacity, and refer to existing and proposed changing lists of prohibited weapons. Doesn't this fall outside the scope of my work for this contract?

#### ANSWER 1:

The Controlled Goods Program (CGP) applies. It applies to Examining, possessing or transferring of controlled goods. However, there are exceptions to certain goods and exemptions for certain individuals which may apply.

The CGP website contains additional information and a phone number to call if further information is required.

Controlled goods: Examining, possessing or transferring - Canada.ca (tpsgc-pwgsc.gc.ca)

The examiner should not be classifying firearms, as that's not what we need and is not part of the Statement of Work.

#### **QUESTION 2:**

When I quit the Forensic Laboratory Services in 2004, I was a civilian member of the RCMP and designated peace officer. I took a commuted value (instead of pension) and received a severance Pay. Must I declare this in my bid?

#### **ANSWER 2:**

As per Section 5.1.3.2 Former Public Servant of the solicitation document (page 11), any former public servants (FPS) in receipt of a pension or of a lump sum payment must provide the information required in this section.

## **QUESTION 3:**

I also briefly saw there was education requirements somewhere. Should I include my certificates of appointment as Forensic Specialist, Firearms Analyst (RCMP), analyst (NS), qualified technician (NB) and court CV? Would a .pdf scan be acceptable?

#### **ANSWER 3:**

As outlined in M3 of the Evaluation Criteria (page 34 of the solicitation document), education requirements were not identified, only the requirement for the Examiner to be a Certified Firearms Analyst from an Accredited Canadian Institution.

A .pdf is acceptable as long as it is legible as per M3 of the Evaluation Criteria.

## **QUESTION 4:**

I was told the bond rooms maintain a log of firearms therein? All of them are issued a number. Apparently is called a PAIN number (Public Agency Identification Number?) Must I record this number in my file?

#### ANSWER 4:

Yes, the bond rooms maintain a log of the firearms. The PAIN number is not be used, rather the Property Exhibit Number generated by the PROS file must be recorded on the Forensic Report. This does not affect the bidding process.



## **QUESTION 5:**

I think there was some form of security screening when I signed the present contract I working under but I'm not sure.

## **ANSWER 5:**

Security requirements on each file may be different and may require additional security checks prior to contract award. For this requirement, the security requirement is as outlined in Annex C (page 27).
