- c) two (2) trucks with a minimum gross vehicle weight registered (GVWR) 6,800 kg (at least one with hydraulic trail gate)

The request for a Tractor trailer. We have been in business for over 20+ years exclusively providing Office Relocation Services in the NCR, and we have had the request for a tractor trailer with our federal government clients ZERO times.

In our experience 95% of the buildings cannot accommodate a tractor trailer for office moving requirements even if we can get one into a building the other building they are moving to cannot accommodate a TT.

Instead using 5-tonne trucks and/or smaller are used to service these buildings as well as ensure a proper flow during moving services.

While we may not "own" one we do have the ability to provide a Tractor Trailer when/if needed but it is not economical from a business standpoint to "own" one as it will seldom, if ever, be required.

We gratefully request this to be changed in the Mandatory's to: be able to provide one (1) tractor trailer when required.
