QUESTIONS AND ANSWERS

A Bidders' Conference was held on January 11th, 2024 at 1:00pm MST. The following questions were raised and answers provided during the Bidders' Conference.

Question 1: In Part 6 – Security states that before award of contract the proposed personnel must hold a valid "Enhanced Reliability Status with Top Secret" Security Clearance issued by RCMP Department Security." Can you please confirm the process of the "Enhanced Reliability Status with Top Secret: Security Clearance? Is there a Public Services Procurement Canada (PSPC) requirement to accompany this clearances request or is it solely a Royal Canadian Mounted Police (RCMP) clearance? Please confirm the length of time to process this clearance.

Answer 1: Solely an "Enhanced Reliability Status with Top Secret" Security Clearance issued by RCMP Department Security" is required. The length of time to process is determined by RCMP Departmental Security Branch and varies from applicant to applicant, depending on the information provided by the applicant. If the applicant hasn't had an RCMP security clearance in the past, it may take more than 3 months for an applicant's *Enhanced Reliability Status with Top Secret* security clearance application to be processed and a decision made. It is the applicant's responsibility to ensure that they provide the information requested by RCMP Departmental Security Branch to RCMP Departmental Security Branch as soon as possible after receiving the request, to ensure that processing the application continues to move forward. Once a contract is awarded, RCMP Departmental Security Branch will provide the applicant with a link to begin the security clearance application electronically.

Question 2: If a company is submitting a bid for two psychologists, how would Annex B be completed for two part time psychologists in Table B? Could an additional table be added?

Answer 2: Two bid packages would need to be submitted for two part time psychologists: one package per psychologist. There are size restrictions per 3.1 of the Request for Proposal for submitting bids by email, so at this time it will be best to receive the bid packages separately. At this time we won't add an additional table, but will consider that for future solicitations.

Question 3: Does section 7.5.3 need to be filled out given it's in the contract portion of the Request for Proposal?

Answer 3: We request that bidders complete section 7.5.3 and 7.14, or that the information be clearly provided in their bid. It would be required to be included in any contracts issued.

Question 4: When does the security clearance screen process begin?

Response 4: Once the technical and financial evaluation of bids is completed, RCMP will send a Notice of Consideration to the bidders who are being recommended for award of contract. The Notice of Consideration will give a contact name for the bidder to contact, to initiate the security clearance screening process. The bidder will be sent a link from Departmental Security Branch to begin the security clearance application electronically. *Enhanced Reliability Status with Top Secret*" Security Clearance must be obtained by the specific person who will be doing work under the contract, before a contract can be awarded.
