#### THIS RFP IS HERBY AMENDMENT AS FOLLOWS:

#### 1. At Part 3 Section II Financial Bid-

#### **REPLACE** with-

Bidders must submit their financial bid as follows:

1) Bidders must submit firm prices, Free Carrier at (Contractor's facility) Incoterms 2010, Applicable Taxes excluded. The total amount of Applicable Taxes must be shown separately. Bidders must provide the address of the Contractor's shipping point at which the Requirement as noted in Annex A will be made available.

#### 6.4.2 Shipping Instructions

- Delivery will be FCA Free Carrier at \_\_\_\_\_(*Contractor's facility*) Incoterms 2010. The Contractor must load the goods onto the carrier designated by the Department of National Defence (DND). Onward shipment from the delivery point to the consignee will be Canada's responsibility.
- 2. Before shipping the goods, the Contractor must contact the following DND Inbound Logistics Coordination Center by facsimile or e-mail, to arrange for shipment, and provide the information detailed at paragraph 3.

- 3. The Contractor must provide the following information to the DND Inbound Logistics Coordination Center when arranging for shipment:
  - a. the Contract number;
  - b. consignee address (for multiple addresses, items must be packaged and labelled separately with each consignee address);
  - c. description of each item;
  - d. the number of pieces and type of packaging (i.e., carton, crate, drum, skid);
  - e. actual weight and dimensions of each piece type, including gross weight;
  - f. full details of dangerous goods/hazardous products, as required for the applicable mode of transportation, signed certificates for dangerous goods/hazardous products as required for shipment by the International Maritime Dangerous Goods Code, the International Air Transport Association regulations or the applicable Canadian <u>Transportation of Dangerous Goods Regulations</u>, and a copy of the safety data sheet in English and French.
- 4. Following receipt of this information by Canada, Canada will provide the appropriate shipping instructions, which may include the requirement for specific consignee address labelling, and the marking of each piece with a Transportation Control Number.
- 5. The Contractor must not ship the goods before receiving shipping instructions from the DND Inbound Logistics contact.
- 6. If the Contractor delivers the goods at a place and time which are not in accordance with the given delivery instructions or fail to fulfill reasonable delivery instructions given by Canada, the Contractor must reimburse Canada any additional expenses and costs incurred.

7. If Canada is responsible for delays in delivering the goods, ownership and risk will be transferred to Canada upon expiry of either 30 days following the date on which a duly completed shipping application is received by Canada or by its appointed forwarding agent, or 30 days following the delivery date specified in the Contract, whichever is later.

Services will be delivered at the location specified in the Statement of Work.

#### 3. At Section 6.14 Packaging Requirement-

# 4. QUESTIONS AND ANSWERS:

Question 01	From our experience it has been very difficult to procure SEA LV2 rebuild kits from the OEM, in many cases it has taken over a year to receive these kits. Does DND have any agreement in place with the OEM to ensure a certain amount of rebuild kits and parts will be made available to the successful bidder to ensure there are no delays?
Answer 01	No, DND does not have an agreement in place with the OEM for parts.
Question 02	Will DND be supplying any current inventory of parts / OEM tool kits to the successful bidder to start this contract?
Answer 02	No, DND does not have an inventory of parts that will be provided.
Question 03	How long after contract award will the handover to the service provider commence?
Answer 03	As soon as possible.
Question 04	What are the DND air sample requirements for filling of the EBS units?

Answer 04	The filling system must be tested for purity at intervals of no less than one year, preferrable every six months.
Question 05	The SOW names 5 locations and infers that there are others that are unnamed. The multiple delivery locations and our company's inability to control shipping costs make it impossible to quote accurate DDP pricing for the expected duration of the contract. We request that the pricing be changed from DDP to FCA Incoterms 2010.
Answer 05	Section II - Financial Bid and the Shipping Terms have been changed from DDP to FCA per the amendments above.
Question 06	It is requested that the Packaging Specification D-LM-008-036/SF-000, DND Minimum Requirements for Manufacturer's Standard Pack, be added to the RFP.
Answer 06	Section 6.14 has been amended to include <i>SACC Manual</i> clause D3018C (2014-09-25) in full text above.
Question 07	We request that the solicitation closing date be changed to 6 March 2024, an extension of 3 weeks.
Answer 07	The solicitation has been extended and the new closing date is now March 06, 2024 at 1400 Eastern Standard Time (EST).
