Requirement Details

Tendering Procedure: Selective Tendering, Conditional Set-aside

The procurement is conditionally set aside under the federal government Procurement Strategy for Indigenous Business if the two (2) conditions below are met. The procurement is conditionally set aside from the international trade agreements under the provision each has for measures with respect to Indigenous peoples or for set-asides for small and minority businesses if the two (2) conditions below are met.

- (i) Bids from two (2) or more Indigenous Businesses are responsive with the mandatory requirements; and
- (ii) Bids from two (2) or more Indigenous Businesses are, in the evaluation team's opinion, not affiliated within the meaning used in the [Competition Act, R.S.C., 1985, c. C-34 \(https://laws-lois.justice.gc.ca/eng/acts/C-34/\)](https://laws-lois.justice.gc.ca/eng/acts/C-34/).

If the above two (2) conditions are not met, the procurement will remain open for competition among all businesses and the following will apply: the World Trade Organization Agreement on Government Procurement (WTO-AGP), the Canada-Chile Free Trade Agreement (CCFTA), the Canada-Peru Free Trade Agreement (CPFTA), the Canada-Colombia Free Trade Agreement (CCoIFTA), the Canada-Panama Free Trade Agreement (CPanFTA), the Canada-European Union Comprehensive Economic and Trade Agreement (CETA), Canada Korea Free Trade Agreement (CKFTA) and the Canadian Free Trade Agreement (CFTA).
