01 TRAINING, EXPERIENCE AND SIZE OF TEAM

The proposed team supervisor must have at least 3 years or 36 months of experience in lawn care and landscape maintenance.

The bidder must indicate the number of employees proposed to perform the tasks of this contract. We estimate that this contract requires a minimum of 4 employees. Any team proposal that does not have the required minimum number of employees will be considered non-compliant.

Note: The bidder must provide a list of the members of the proposed team with the years of experience of each of them, as well as the curriculum vitae (CV) of the supervisor from your company who will be in charge of this contract. This criterion will be considered compliant if the list contains the minimum number of employees required, as well as the CV of the supervisor confirming the supervisor's minimum required experience. The month and year must be clearly identified in the listing and the proposed CV.
