APPENDIX I – INDIGENOUS PARTICIPATION

The Government of Canada encourages Indigenous socio-economic development through federal contracting opportunities, and encourages the Consultant to contribute to creating long-term sustainable and meaningful socio-economic benefits for Indigenous people, businesses and communities.

1. Definitions:

The following definitions apply to the Indigenous participation of the Contract:

 Subcontracting a portion of the Work, or services required by the Consultant to deliver the Work, to a qualified Indigenous Business as defined under the Procurement Strategy for Indigenous Business (PSIB).
 - b. <u>Indigenous Employment:</u>
 Full-time, part-time and casual employment of Indigenous persons as defined under the PSIB.
- (ii) Indirect benefits: Indirect benefits are transactions incurred by the Consultant during performance of the Work that include scholarships, training, and bursaries.
- (iii) Indigenous participation transactions: The total value of all transactions incurred by the Consultant on direct and/or indirect benefits.

2. Indigenous Business Certifications:

Certifications 1 and 2 in Attachment 2 to this appendix - Indigenous Business Certifications should be submitted to the Contracting Authority within 5 calendar days of a request for the certifications. The Consultant should obtain the certifications from the subcontractor(s) before work commences.

3. Indigenous Participation Overview & Status Reports

3.1 Overview:

The Consultant is encouraged to seek and secure direct and/or indirect benefits from Indigenous businesses. The business activities proposed in support of this objective should be in the form of quantifiable transactions.

3.2 Status Reports:

The Consultant is requested to submit Indigenous Participation Status Reports as indicated in SC 8 and Appendix G Indigenous Participation Reporting.
