Question 1

In Annex A, under the Mandatory Technical Specifications 2.0, can you please clarify the specification for the OAP Mirror line # 13: The mirror must have edges: Ground, square with front surface to within +/-0.5 deg.

Answer 1



This means that the cylindrical edge surface of the mirror must be cut at 90deg (+/-0.5deg) from the tangent plane to the front (polished) surface at center. (This plane can also be defined as the best-fit plane of the mirror front surface). The edge must have a ground finish.
