

The purpose of Amendment 003 is to:

1)

Question 1:

Regarding section 7.3 of the Statement of Work (SOW), we request that the ATSSC provide clarification on the "at the request of the public parties" clause. Specifically, does this simply allow for the contractor and the parties to negotiate their own terms for expedited delivery on a case-by-case basis, or is it intended to enforce a blanket requirement for the contractor to always have the transcript prepared by the following morning, regardless of the initial delivery schedule agreement?

Answer 1:

This is confirmation that section 7.3 is intended to allow the contractor and the parties to negotiate their own terms for expedited delivery on a case-by-case basis.

Provisional follow-up to question 1:

Should the ATSSC affirm that the interpretation of section 7.3 of the SOW indeed mandates a blanket requirement for next-morning preparation of the transcript regardless of the initial delivery agreement, we respectfully request a re-evaluation of this stipulation due to its substantial implications for operational feasibility and financial sustainability.

We understand and respect the ATSSC's intention to ensure timely access to hearing transcripts for public parties. However, enforcing a universal next-morning turnaround, irrespective of pre-agreed delivery schedules, imposes significant operational and financial challenges. These include the necessity for continuous resource readiness that would inherently drive up costs—costs not accounted for in standard pricing models, which are typically contingent on negotiated delivery timelines. The requirement for such an expedited service, without the allowance for corresponding adjustments in service fees, risks making contract fulfillment economically unviable.

Given these considerations, we request that this requirement be adjusted to ensure it aligns with the realities of operational logistics and cost structures.

Answer 1:

This is confirmation that the ATSSC does not want to enforce a universal next-morning turnaround, irrespective of pre-agreed delivery schedules. However, the supplier should have the resources to deliver next day transcripts to parties should they request it. This will be on a case-by-case basis between the parties and the supplier.

Question 2:

In reference to the "Transcript of real-time captioning" pricing tables, we have observed that the "Estimated quantities for evaluation purposes only" column does not contain any figures. Could you please clarify whether this omission indicates that the services listed will not be subject to financial evaluation? If they will indeed be evaluated financially, could the ATSSC provide the expected quantities or weighting that will be used for each service during the evaluation process? This information is crucial for us to accurately prepare our bid and ensure our pricing structure aligns with the ATSSC's evaluation criteria.

Answer 2:
