- Q2.** If a proponent is currently available 7 am - 7 pm in Nunavut, and has plans to expand to 24/7 after the contract is awarded, is that acceptable?

- Q3.** Please advise if there is currently a Contractor or company performing these services.
- A3.** Yes, the current Contractor performing these services is PRAXES Medical Group.
