Q1. The RCMP recently released an RFP for design services of two detachments at Fox Lake, AB and Montreal Lake, SK. The RFP has now been revised to make consultants' travel expenses reimbursable. Can a similar approach be applied to this RFP? If not, please provide more details on the anticipated site visits during each project phase for a fair evaluation.

A1. Price proposal to be per Appendix C - Price Proposal Form. Refer to PA 6.10 Meetings, and RS 6.3 Details.

Q2. Page 5 of 46 1. Integrity Provisions – Declaration of Convicted Offences references R1410T (2022-01-28), General instructions 1 (GI1), Integrity Provisions – Proposal, section 3b. And on page 29 of 46, 2. Integrity Provisions – Declaration of Convicted Offences, references R1410T (2020-05-28), General instructions 1 (GI1), Integrity Provisions – Proposal, section 3b. Which reference is correct for the Integrity provisions?

A2. The correct reference would be R1410T (2022-01-28).

Q3. For the Integrity Provisions, since we don't have any criminal convictions, we normally submit the attached List of names for integrity verification form, from PWGSC. Is this acceptable?

A3. The form from PWGSC is acceptable.

#### Q.4 When submitting our proposal, we noted the 3 specific sections In Section I TECHNICAL PROPOSAL which will includes APPENDIX-B TEAM IDENTIFICATION in Mandatory section and RATED REQUIREMENTS. Section II will include FINANCIAL PROPOSAL. Section III DECLARATION/CERTIFICATIONS which will include APPENDIX-E DECLARATION/CERTIFICATIONS FORM, do we include List of names for integrity verification form in Section III?

A4. The Integrity Form would be included with the documents included as per Section III - Declaration/Certifications.

# Q5. Front page of the RFP Solicitation; and, Front pages of revision(s) to the RFP, would these be appended to Technical Proposal, or included in Mandatory Section of Technical Proposal?

A5. These pages would be included in the Technical Proposal.

Q6. On page 41 of 46 Rated Requirement 1: Achievements of Proponent on Projects, (e) Describe how the proposed team has successfully performed services previously (10 pts), what is expected as response to this specific item for each project?

A6. Rated Requirement (e) evaluation will be emphasized on how the services were provided as a team.

Q7. For Rated Requirement 3: Should the requested CV be part of the response for R3 or appended to Technical Proposal ? Also there is no mention of Civil Engineer; Landscape Architect; and Building / Fire Code Engineer, identified in the TEAM IDENTIFICATION form and in Appendix A Project Brief, should we include CV for these roles as well?

A7. Refer to Q12 for clarification.

## Q8. For Rated Requirement 4: item c) Significant issues, challenges and constraints has no assigned points ?

A8. Rated Requirement 4, item c) to be allotted 10 pts.



# Q9. Rated Requirement 3, item (d) states *Two comparable projects (do not list the same projects as R1).* Since some of the Key Personnel are Subconsultants, can we list some of the same projects as R2 for their 2 projects?

A9. Yes, response is at the discretion of the proponent. Rated requirement will be evaluated accordingly.

### Q10. Under Rated Requirement 3 RCMP does not request CV's for Civil Engineer, Landscape Architect and Building/Fire Code Engineer. Are proponents expected to include these as part of the evaluation?

A10. Refer to Q12 for clarification.

### Q11. Some of the key specialties are not province-specific licensed professions, how will RCMP evaluate this under the Mandatory Requirements?

A11. At minimum, and where applicable, disciplines must be a member of a Saskatchewan Association relating to their field and or represented by licensed Architect in the Province of Saskatchewan. To clarify, Landscape Architect(s) to be a member of the Saskatchewan Association of Landscape Architects (SALA). Interior Designer(s) to be a member of Interior Designers' Association of Saskatchewan.

This list excludes Code and Landscape.

Then on page 42 of the RFP under Rates Requirement 3: the proponent is to provide a one page resume for the following roles:

**Electrical Engineer** 

Sustainable Development Specialist/Engineer

**Commissioning Specialist** 

**Costing Consultant** 

This list also omits Code and Landscape.

The Project Brief PD 4.9 through to PD 4.17, lists the following: Architectural, Civil., Structural, Mechanical, Electrical, Code, Commissioning, Costing, Sustainable Development.

Given that the above lists are inconsistent, could you please confirm the disciplines and roles that must be included in our response.

### Q13. Similar to other RCMP proposals, could you please provide a comprehensive Class D Cost Estimate that includes construction contingencies, escalation/risks and furniture associated costs? This will allow all Proponents to calculate their fees on the same figure.

### Q14. Could you confirm whether resumes can be excluded from the page count and be included in the appendix?
