PART 1 - GENERAL INFORMATION

1.1 Security Requirements

There is no security requirement associated with this bid solicitation.

1.2 Statement of Requirement

This Statement of Requirement (SoR) outlines the need to procure data specifications regarding Air Fare Data, Flight Data, Passenger Data, Operations Data, Fleet Data, and Financial Data.

The Contractor must be able to provide the items detailed under the "Requirement" at Annex A.

1.3 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1.4 Trade Agreements

All [Trade Agreements](#) are applicable.

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The [2003](#) (2023-06-08) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

2.2 Submission of Bids

Bids must be submitted only to the Canadian Transportation Agency (CTA) at email address OTC.soumission-bid.CTA@otc-cta.gc.ca by the date, time and place indicated in the bid solicitation.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than ten (10) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Quebec.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

2.5 Bid Challenge and Recourse Mechanisms

- (a) Several mechanisms are available to potential suppliers to challenge aspects of the procurement process up to and including contract award.

Section III: Certifications

Bidders must submit the certifications and additional information required under Part 5.

Section IV: Additional Information

Bidders may submit any other information related to the requirement.

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

4.1 Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

4.1.1 Technical Evaluation

4.1.1.1 Mandatory Technical Criteria

Each bid will be reviewed for compliance with the mandatory requirements of the bid solicitation. All elements of the bid solicitation that are mandatory requirements are identified specifically with the words “must” or “mandatory”. Bids that do not comply with each and every mandatory

requirement will be considered non-responsive and be disqualified. Mandatory evaluation criteria are described in Annex C Evaluation Criteria.

4.1.1.2 Point Rated Technical Criteria

Each bid will be rated by assigning a score to the rated requirements, which are identified in the bid solicitation by the word "rated" or by reference to a score. Bidders who fail to submit complete bids with all the information requested by this bid solicitation will be rated accordingly. The rated requirements are described in Annex C Evaluation Criteria.

4.1.2 Financial Evaluation

4.2 Basis of Selection

4.2.1 Highest Combined Rating of Technical Merit and Price

SACC Manual Clause ([A0027T](#)) (2022-12-11), Highest Combined Rating of Technical Merit and Price

1. To be declared responsive, a bid must:
 - a. comply with all the requirements of the bid solicitation; and
 - b. meet all mandatory criteria; and

The Bidder(s) that pass all mandatory criteria and has the highest combined technical and financial score(s) per each data type will be recommended for contract award.

Canada may award one (1) Contract per dataset. In order to be awarded one (1) Contract for one or more datasets the bidder must achieve the highest overall rating for the datasets for which they bid.

Canada may award up to six (6) contracts as a result of this RFP.

2. Bids not meeting "a and b" will be declared non-responsive.
3. The selection will be based on the highest responsive combined rating of technical merit and price. The ratio will be 75% for the technical merit and 25% for the price.
4. To establish the technical merit score, the technical score per dataset will be determined as follows: total number of points obtained / maximum number of points available multiplied by the ratio of 75%.
5. To establish the pricing score, each responsive bid per dataset will be prorated against the lowest evaluated price and the ratio of 25%.
6. For each responsive bid per dataset, the technical merit score and the pricing score will be added to determine its combined rating.
7. Neither the responsive bid per dataset obtaining the highest technical score nor the one with the lowest evaluated price will necessarily be accepted. The responsive bid per dataset with the highest combined rating of technical merit and price will be recommended for award of a contract.

The table below illustrates an example where all three bids are responsive and the selection of the contractor is determined by a 60/40 ratio of technical merit and price, respectively. The total available points equals 135 and the lowest evaluated price is \$45,000 (45).

PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

5.1 Certifications Required with the Bid

The Contractor grants to Canada the irrevocable option to extend the term of the Contract by up to four (4) additional one (1) year period under the same conditions. The Contractor agrees that, during the extended period of the Contract, it will be paid in accordance with the applicable provisions as set out in the Basis of Payment.

Canada may exercise this option at any time by sending a written notice to the Contractor at least thirty (30) calendar days before the expiry date of the Contract. The option may only be exercised by the Contracting Authority, and will be evidenced for administrative purposes only, through a contract amendment.

ANNEX A – STATEMENT OF REQUIREMENT (SOR)

1. Scope

1.1. Identification

This Statement of Requirement (SOR) identifies the work to be performed to acquire data requirements regarding Air Fare Data, Flight Data, Passenger Data, Operations Data, Fleet Data, and Financial Data.

1.2. Background

The Canadian Transportation Agency (CTA) acts as a tribunal and regulator with the power of a superior court in the transportation sector. Its mandate is to federally regulate different modes of transportation (air, rail and marine). It has three key focuses:

- To help ensure that the national transportation system is run efficiently and smoothly in the interest of all Canadians;
- To protect the human rights of people with disabilities to have an accessible transportation network;
- To provide protection for air passengers.

To support its focuses, the CTA makes decisions based on research and data analysis of the transportation sector. The CTA uses analytical results from industry issues, trends, and risks to inform reporting, legislative review, regulatory drafting, impact assessments, and policy development.

1.3. Purpose

The CTA has a requirement for:

- Air Fare Data on all Canadian and foreign air carriers** to conduct regulatory impact assessment on fare prices, as well as general studies on air prices and the air industry;
- Flight Data on all Canadian and foreign air carriers** to conduct further analysis informing the state of the air carrier's performance in Canada and to assess compliance with the new Air Passenger Protection Regulations (APPR);
- Passenger Data on all Canadian and foreign air carriers** to classify large or small air carriers under the APPR and Accessible Transportation for Persons with Disabilities Regulations (ATPDR), as well as to conduct general analysis of the air industry;
- Operations Data on Canadian air carriers** to identify large and small transportation service providers in the ATPDR;
- Air Carrier Fleet Data on Canadian air carriers** to inform effective compliance promotion, monitoring, verification and enforcement of CTA-related legislation and regulations, and;
- Financial Data on foreign air carriers** to identify the corresponding implication foreign air carriers have on the Canadian air industry, related to air carriers that flies to / from and within Canada.

1.4. Scope of Requirement

The below scope of requirement applies to the contract awarded to the requested datasets:

- The transfer must be done via CTA's approved file transfer service (such as FTP, API, or an alternate mean of communication that doesn't consist of a portal log-on);
- Upon receiving the data, the CTA will have four (4) weeks to import and verify the data;
- The Contractor agrees to answer any questions from the CTA within two (2) business days;
- Should there be any issues with the data format, the Contractor agrees to re-submit the data within three (3) business days, as requested by the CTA.

1.5. Accessibility Criteria

All deliverables must be in .csv format.

1.6. Deliverables

The deliverables must be delivered through the CTA's approved file transfer service (such as FTP, API, or an alternate mean of communication that doesn't consist of a portal log-on).

1.7. Acceptance

The Project Authority shall acknowledge the acceptance of deliverables under separate correspondence. If the contractor has not received a notification to the contrary within ten (10) working days, the deliverable will be deemed to have been accepted.

1.8. Government furnished equipment

Government furnished equipment is not necessary for the delivery of the datasets in this SOR.

2. Data item descriptions

2.1 Fare Data

a. Deliverable and Acceptance Criteria

Requirements for the deliverable include:

- The deliverable is the completed transfer of the required data to CTA and the provision of service support as and when requested.
- As per the data specifications in Appendix A and B, the Contractor must transfer all Canadian and Foreign fare records of flights into and out of Canadian airports monthly for all applicable months of the contract period. The required data fields are listed in section 2.1.c of this SOR.

The acceptance criteria include:

- The Fare Data fields to be provided must include the categories listed in section 2.1.c (Data Points) of this SOR and follow the criteria listed;
- Monthly Fare Data files must be submitted for each month within five (5) business days from the end of that month;
- The time frames indicated in the scope of requirement must be respected;
- The mode of transfer must be via CTA's approved file transfer service (such as FTP, API, or an alternate mean of communication that doesn't consist of a portal log-on);
- The Contractor must transfer the data in a .csv format;
- The Contractor must provide sources of data and collection methodology;
- The Contractor must provide methodology and codebook regarding data quality assessment, if applicable;
- The Contractor must provide data definitions that include at a minimum data description, data type, and data size; and,
- If changes are made to the dataset, the Contractor must notify the Project Authority, resend the entire dataset originally submitted with a summary of the changes and new data definitions, all in a consistent manner as per previously sent.

b. Timeframe and Delivery Dates

The Contractor must provide the data within five (5) business days of the start of the subsequent month. The Contractor must provide to the Project Authority the complete set of Fare Data records monthly for the months of the contract period.

For instance, if the contract is approved (awarded) on April 17, 2024, the initial transfer would include all data from April 1 to April 30, 2024.

c. Data points

The Data to be provided must include, at a minimum, the fields shown below in the table. Each data field must be completed when available or applicable. The Data provided by the resulting Contractor does not have to be presented in the order shown.
