Question 9

We are wondering if we can use our resource experience of over 7 years average instead of that of our organization which is ~ 6 years (May 2017 incorporated)?

Answer 9

No, VRAB will not accept the resource's years of experience as meeting this requirement.

Question 10

Would the evaluator consider changing the MT2 requirement to 5 yrs as that's a long enough duration in our opinion in the eLearning industry to demonstrate one's capability to deliver? I am sure that will help Canadian based companies like our to participate and contribute meaningfully in such Federal programs.

Answer 10

No, the experience requirement for MT2 will remain at 7 years of experience.

Question 11

For RT 1 – is eCampus considered a Provincial Agency?

Answer 22

VRAB uses Microsoft Word as the preferred authoring tool. There is no preferred course framework.

Question 23

Can you elaborate on why the RFP was issued halfway through the project? Was the workload too much? Was another vendor not able to complete the work? Some other reason?

Answer 23

In the fall of 2022, VRAB entered into a contract to address an urgent and immediate need for specific elearning modules. The modules were required to train newly hired VRAB employees. The work VRAB is requesting under this RFP will be to continue building on and creating additional modules for various learners.

Question 24

For the training that still needs to be completed/developed, where are you at with the content? Is it completed, does it require substantial editing from the successful vendor?

Answer 24

There is still a great deal of content that needs to be created. Our in-house Online Learning Project Lead works with our Subject Matter Experts (SME) to create the Content Documents (CD). After the first draft

of a CD is designed, it will be sent to the successful Contractor. Subsequent drafts of the CD will be required to move between VRAB and the successful Contractor before final sign-off is given and it is sent for courseware development. We will follow a review/editing process that will work efficiently between the two parties.

Question 25

Is the majority of course content already available in a sharable format, such as text documents, videos, or slides, or will subject matter experts and the Contractor work together to draft them from scratch during the project?

Answer 25

The already-developed course content is available in a sharable format, such as text documents, or slides. Our in-house Online Learning Project Lead works with our Subject Matter Experts (SME) to create the Content Documents (CD). After the first draft of a CD is designed, it will be sent to the vendor. Subsequent drafts of the CD – typically three drafts – will be required to move between VRAB and the vendor before final sign-off is given and it is sent for courseware development. SMEs and the Contractor will not be working together to draft content from scratch.

Question 26

Is there a preferred vendor to take over the work? Have you had a discussion with one already about completing the work?

Answer 26

No, there is not a preferred vendor to continue this work. No, VRAB has not had any conversations about completing this work.
