Supply of Liquid Handler for Protein Crystallization

1. Advance Contract Award Notice (ACAN)

An ACAN is a public notice indicating to the supplier community that a department or agency intends to award a contract for goods, services or construction to a pre-identified supplier, thereby allowing other suppliers to signal their interest in bidding, by submitting a statement of capabilities. If no supplier submits a statement of capabilities that meets the requirements set out in the ACAN, on or before the closing date stated in the ACAN, the contracting officer may then proceed with the award to the pre-identified supplier.

2. Definition of the requirement

The National Research Council of Canada has a requirement for the supply of one liquid handler for protein crystallization. The system must be able to set up hanging drop, sitting drop, micro batch and seeding crystallizations in a 96 well format.

- 3. Criteria for assessment of the Statement of Capabilities (Minimum Essential Requirements)
 - Any interested supplier must demonstrate by way of a statement of capabilities that its system meets all of the following requirements:
 - The system must include the hardware and software required to set up hanging drop, sitting drop, micro batch and seeding crystallizations in a 96 well format.
 - o The system must be able to deliver volumes as low as 25 nanoliters
 - The system must be capable of multiple aspirations with single dispense
 - o The system must be capable of a single aspiration with multiple dispenses.
 - The instrument must have a humidifying chamber with humidity fully controlled by the software.
 - The system must be able to complete a 96 well setup in less than 3 minutes.
 - Liquid delivery must be by true positive displacement.
 - The system liquid delivery must eliminate any chance of cross-contamination of sample or reservoir solutions.
 - System operation and maintenance must not require washing steps.
