**Question 1:**

Should our firm be successful in our bid pursuit, our delivery team is based in a Central Standard time zone which means 2hrs in arrears during the winter months. Please confirm this is acceptable with your client, as our team would be available at 9am EST and could also be available for an extended period during the evening.

**Answer 1:**

The availability at 9 am is acceptable, but no later.

**Question 2:**

Regarding RT3, please confirm that experience with a Provincial or Municipal Web Experience Toolkit (WET) would also be acceptable here.

**Answer 2:**

Provincial or Municipal Web Experience Toolkit (WET) is not acceptable, we require Federal government experiences only.

**Question 3:**

Under Rated Requirement #3 - RT3 - your client has requested experience with the Govt of Canada Web Experience Toolkit (WET) and Web Accessibility Standard. Could the Crown kindly confirm that experience with Bootstrap 4 would satisfy this requirement since it is tremendously similar to WET and is extensively used outside of the Crown?

**Answer 3:**

No, Bootstrap 4 would not satisfy this requirement. I would say that knowing Bootstrap is a good base, but the WET is also everything regarding accessibility, look and feel, etc.

**Question 4:**

Could the Crown kindly confirm the anticipated LOE in each of the 2 years of this engagement? This will assist in pricing.

**Answer 4:**
