Request for Proposal – Department of National Defence (DND) Requirement – Match Fuzee

The subject Request for Proposal, (RFP) is amended as detailed below. This amendment to the RFP includes the following:

- Publication of questions submitted by potential bidders and answers to the submitted questions; and,
- Modifications to the Request for Proposal.

1.0 Questions and Answers

- Question 1: The solicitation document requires bids to be submitted on the basis of; "Delivered Duty Paid (DDP) at destinations, Incoterms 2010". Would it be acceptable for bids to be submitted on a Delivered at Place (DAP) Incoterms basis?
- Answer 1: With a view to reduce supply chain challenges that may be experienced by bidders, the terms of the Bid Solicitation are revised from "Delivered Duty Paid (DDP)" at destinations, Incoterms 2010", to goods delivery Incoterms 2010 FCA Free Carrier at the Contractor's shipping point and electronic documentation delivery.
- Question 2: The solicitation document requires bids to be submitted in Canadian dollars. Our products are normally sold in other currencies. In order to offer the best pricing possible, would it be acceptable to bid in an alternate currency, such as USD, EUR, or GBP?
- Answer 2: With a view to support GoC objectives of best value, the terms of the Bid Solicitation are revised to permit the submission of bids in a foreign currency. However, financial bid evaluation needs to be undertaken using a common baseline. Therefore, bids submitted in a foreign currency will be converted to Canadian currency for evaluation purposes. The rate given by the Bank of Canada in effect on the bid solicitation closing date, will be applied as a conversion factor to the bids submitted in foreign currency. The resulting contract will be awarded based on the currency identified in the bid.
- Question 3: The requirements listed in Part 6 of the Bid Solicitation, Annex "C" Ammunition Manufacturer's Data Card Instructions, are more appropriate for ammunition and explosives. As most of the information listed in ANNEX C would not apply, the requirements of Annex "C" should be reconsidered.
- Answer 3: Part 6 of the Bid Solicitation, Annex "C" Ammunition Manufacturer's Data Card Instructions, together with Part 6 of the Bid Solicitation, Annex "A" – Statement of Work have been updated as detailed herein.

- Question 4: The requirements listed in Part 6 of the Bid Solicitation, Annex "D" Ammunition Package Marking Instructions – Small Arms Ammunition, are more appropriate for ammunition and explosives. As most of the information listed in ANNEX D would not apply, the requirements of Annex "D" should be reconsidered.
- Answer 4: Part 6 of the Bid Solicitation, Annex "D" Ammunition Package Marking Instructions has been updated to reflect non-explosive items.
- Question 5: The requirements listed in Part 6 of the Bid Solicitation, Annex "E" Ammunition Manufacturer's Lotting Instructions can be met as per US DOD MIL-STD 1168C. Would this be acceptable?
- Answer 5: US DOD MIL-STD 1168C is an acceptable alternative. Part 6 of the Bid Solicitation, Annex "E" – Ammunition Package Marking Instructions has been updated to permit performance of the Work in accordance with US DOD MIL-STD 1168C or Annex "E", as currently written.

1.1.1 The purpose of this Statement of Work (SOW) is to describe the Department of National Defence (DND) requirements for the acquisition and its support of the Match Fuzee.

1.2 <u>Background</u>

1.2.1 The Match Fuzee is a safety strike match that is both windproof and waterproof to produce a burn. When struck, the tip of the match flames and ignites the main composition, which burns red hot without a flame, evolving only smoke for the total composition length. They are primarily used in military applications for the lighting of fuses, but are also used by fire departments.

3. **REQUIREMENTS**

3.1 General

3.1.1 The Contractor must supply a Match Fuzee and associated documentation meeting all requirements identified within this SOW.

3.2 **Product Requirements**

- 3.2.1 The Match Fuzee must meet the requirements identified within this section.
- 3.2.2 <u>Compatibility Requirements</u> The Match Fuzee must:
- 3.2.2.1 be compatible with, and provide consistent ignition of the Fuse Blasting Time M700 safety fuse in use with the Canadian Armed Forces.
- 3.2.3 <u>Performance Requirements</u>. The Match Fuzee must:
- 3.2.3.1 burn with low flame after ignition;
- 3.2.3.2 be wind resistant; and
- 3.2.3.3 have a total burn time between 6 to 18 seconds after ignition.
- 3.2.4 <u>Packaging Requirements</u>. The Match Fuzee must:
- 3.2.4.1 be packed with 10 Match Fuzee and one Striker per individual package; and ,
- 3.2.4.2 be packaged, have required markings, and transported in accordance with current and applicable Transportation of Dangerous Goods Regulations (SOR 2001/286), or UN Recommendations on the Transport of Dangerous Goods – Model Regulations Rev 22.
- 3.2.5 <u>Service Life Requirements</u>. The Match Fuzee must:
- 3.2.5.1 have less than 12 months of age from the date of manufacture at time of delivery.




Fig 2. Example of a diagram of packaging




Fig 3. Example of an engineering drawing of packaging
