Solicitation Amendment No. **002**

This solicitation is hereby amended to provide the following questions and answers.

Q2. If my organization recently obtained, renewed or upgraded its security clearance, will I be required to complete a new Application for Registration Form to bid on a new solicitation with security requirements?

R2. Yes, organizations that are already screened by the Contract Security Program and that are bidding on a new solicitation will need to complete the Application for Registration form as part of their response.

Q3. Would the successful proponent be precluded to bid on future projects related to this assignment?

R3. As per the *Eligibility for Related Requests for Proposal (Contracts) - Annex A – Statement of Work*, the Contractor that is awarded this contract (T8080-220475/A) will not be eligible to apply for subsequent contracts related to this work. Any proposal received from future Requests for Proposal by Transport Canada related to aviation studies of Southern Ontario from bidder(s) or affiliate firms that are successful in this bid will not be eligible and will not be evaluated.
