## IMPORTANT NOTICE TO BIDDERS

## TWO STAGE SELECTION PROCESS

This is the first stage (Stage one) of a two-stage competition: the first stage will evaluate the qualifications of all bidders; second stage (Stage two) will invite the qualified bidders to provide a financial bid on the project based on the specifications and drawings. Upon award of contract in Stage Two the pre-qualification list will expire and will not be used in any other solicitation. The qualification list will expire within 180 days or upon award of a contract in Stage Two, whichever is earlier, and the prequalification list will not be used in any other solicitation.

Please note that the ITT used in Stage 2 of this process will be a Single Envelope ITT with a Low Price Basis of Selection. ## **ENQUIRIES DURING THE SOLICITATION PERIOD**

## APPENDIX 1 – STAGE ONE QUALIFICATION REQUIREMENTS

#### **DESCRIPTION:**

Parks Canada requires a Prime General Contractor with heavy civil construction experience to perform the required renovation work along Highway 431 (approx. 12.4km) between the communities of Woody Point and Trout River within Gros Morne National Park, NL. In addition, the contractor will be required to reconstruct the existing access and parking lot located at the Tableland's Trail head.

The scope of work shall consist of and is not limited to ditching, channel excavation (Dry Brook), culvert replacements, culvert extensions, concrete headwall placements; guide rail replacement, asphalt cold planning, asphalt pulverization, asphalt resurfacing (2-lifts), asphalt gutter installation, shouldering and renovation work required for the Tableland's Trail Parking area redevelopment.

Further to the scope of work, bidders are advised that 15 to 20% of recycled asphalt is to be utilized in the lower lift along Highway 431– no exceptions.

Bidder Instructions: The Bidder is requested to respond to the Phase One Evaluation Criteria using the tables below.

#### BASIS OF SELECTION:

A submission must comply with the mandatory requirements to be declared responsive in Stage One.

#### MANDATORY REQUIREMENTS:

At Stage One bid closing time, the Bidder must:

- a) comply with the following Mandatory Requirements; and
- b) provide the necessary documentation to support compliance.

All Mandatory requirements should be completed and submitted prior to closing with sufficient detail to demonstrate compliance. Failure to demonstrate compliance with all mandatory requirements via the original submission, may result in the submission being deemed non-responsive. At any time in the evaluation stage should PCA officials identify any minor irregularities or omissions the Contract Authority may inform the proponent of a time frame within which to provide a clarification or missing information. Failure to comply with the request of the Contracting Authority within the time frame provided will render the submission non-responsive.

Select two (2) reference projects undertaken by the Bidder within the last 5 years for each **mandatory** requirement. A response to each **mandatory requirement** is required. Only the first two (2) projects listed for each, in sequence, will receive consideration and any others will not receive consideration.
