Description of the Requirement:

The Department of Foreign Affairs, Trade and Development's (DFATD) International Platform Branch (ACM), Professional and Technical Services (AWD), has identified a requirement to secure professional services to support the delivery of its programs on an as and when requested basis.

DFATD's Visual Art Collection (VAC) program acquires and circulates work by Canadian artists to Canada's missions in 108 cities worldwide. Initiated in the 1930s, the program now manages some 6,500 works of art in all media (painting, drawing, watercolour, collage, textiles, photography, video, sculpture, ceramics, and glass).

Given the large portfolio of art, the scope of this contract is to secure professional services for a period of two (2) years with an additional three (3) one-year option periods to support the VAC program.
