

## Notice of Proposed Procurement (NPP) Template – Solicitation # 2023-01154

This bid solicitation cancels and supersedes previous bid solicitation number 2023-01154 dated April 25<sup>th</sup>, 2023 with a closing on May 5<sup>th</sup>, 2023 at 2pm EDT. A debriefing or feedback session will be provided upon request to bidders / offerors / suppliers who bid on the previous solicitation.

1. This NPP is issued pursuant to PWGSC Supply Arrangement (SA) # **E60PQ-140003/C** and covers a requirement from the following Product Categories of the SA:
  - a. **Product Category 1** - Interconnecting Panels and Freestanding Systems;
  - b. **Product Category 2** - Freestanding Height Adjustable Desk/Table Products;
  - c. **Product Category 5** - Ancillary and Lighting Products
  - d. This requirement also contains **products that are NON-SUPPLY ARRANGEMENT**.
2. The **Canadian Food Inspection Agency** (CFIA) (the « **Client** »), has a requirement for the purchase, delivery and installation of office furniture to Mirabel, QC by **July 12<sup>th</sup>, 2023**.
3. This NPP covers a requirement to be solicited amongst the General Stream (SA holders) and the PSIB stream of Suppliers (SA holders).
4. This procurement is conditionally set aside under the federal government Procurement Strategy for Indigenous Business. For more information on Aboriginal business requirements of the Set-aside Program for Indigenous Business, refer to [Annex 9.4](#) of the Supply Manual.

This procurement is conditionally set aside from the international trade agreements under the provision each has for measures with respect to Aboriginal peoples or for set-asides for small and minority businesses. Further to Article 800 of the Canadian Free Trade Agreement (CFTA), CFTA does not apply to this procurement.

This is a competitive bid solicitation however, this solicitation will be reserved for Indigenous Businesses if both of the conditions detailed in the Request for Proposal (RFP) are met. If the conditions are not met, the procurement will remain open for competition among all suppliers.

This requirement is subject to the Canadian Free Trade Agreement (CFTA).

5. There is no security requirements associated with the requirement.
6. Only suppliers who are pre-qualified and have been issued a supply arrangement are eligible to bid.
