Bidder Question #5	Is CORE open to including organizations in the roster of investigators who do not possess competencies in the full range of human rights issues described in the RSFO document? For example, are organizations that specialize in child labor encouraged to apply even if they do not have expertise in land rights, anti-discrimination, etc.?

DFATD Response	The intention of Attachment 1 – Mandatory Technical Criteria is for the firm/company/organization to demonstrate corporately the capability/previous experience providing the services listed in each Evaluation Option. The project summaries are from a Corporate perspective, not individual resource perspective. If the company is a sole proprietor, the response is still from a company perspective. Individual investigators will be evaluated at the time of call up based on the company's Standing Offer using Mandatory Criteria for Call-Ups – For Proposed Resources (pages 16- 17) and Attachment 1 to Part 7. Please also review 7.8 Call Up Procedures (page 33)
