- **Q3.** If we were to get pre-qualified and we receive a quote from a mason that was not carried in our pre-qual, are we able to substitute or do we need submit more than 1 pre-qual form for each sub we want to get pricing from. As the tender drawings and docs will not be released until after the stage 1 portion and pricing will not be available until the stage 2 portion of the tender.
- A3. Please submit the required information for the principal masons (up to three) that you are considering for the project. If a mason does not pass the qualification criteria for a principal mason, they cannot be used on the project in that role.
