QUESTION NO. 1:

As stated within Criteria R2: "The bidder SHOULD identify up to three projects or assignments, per proposed resource, that demonstrate their relevant experience to the scope of work across supply chains as outlined in the Statement of Work." The criteria indicates per proposed resource, however, each project is a maximum of 10 points to add up to 30 points. Should a group of team members be presented, how will the points be allocated / scored?

ANSWER NO. 1:

Bidders are expected to provide projects or assignments that demonstrate their relevant experience to the scope of work outlined in the Statement of Work per Criteria R2. The examples provided are not required to be the same as those listed under Criteria M5. Points will be awarded based on relevance of listed projects or assignments to the Statement of Work for the proposed resources. Each listed project that is deemed as relevant will be awarded 10 points up to a maximum of 30 total points.
