PART 1. - GENERAL INFORMATION

This bid solicitation cancels and supersedes previous bid solicitation number 30002646B dated April 24, 2023 with a closing of May 26, 2023 at 2:00 pm (Eastern Standard Time). A debriefing or feedback session will be provided upon request to bidders/offerors/suppliers who bid on the previous solicitation. This solicitation is open tender and not under the ProServices supply arrangement.

1.1. Introduction

The bid solicitation is divided into six parts plus attachments and annexes, as follows:

- Part 1 General Information: provides a general description of the requirement:
- Part 2 Bidder Instructions: provides the instructions, clauses and conditions applicable to the bid solicitation;
- Part 3 Bid Preparation Instructions: provides Bidders with instructions on how to prepare their bid;
- Part 4 Evaluation Procedures and Basis of Selection: indicates how the evaluation will be conducted, the evaluation criteria that must be addressed in the bid, and the basis of selection;
- Part 5 Certifications and Additional Information: includes the certifications and additional information to be provided:
- Part 6 Resulting Contract Clauses: includes the clauses and conditions that will apply to any resulting contract.

1.2. **Summary**

Fisheries and Oceans Canada (DFO) requires the services of one or more senior fisheries science analysts to provide an evaluation and statistical performance review of the technical elements of Fisheries and Oceans Canada's ("DFO") "A Fishery Decision-Making Framework Incorporating the Precautionary Approach" ("PA Policy", DFO 2009a), and technical analyses of potential revisions, additions or clarifications to the PA Policy, taking into account:

- the need to implement the PA Policy across diverse species life histories and data availabilities.
- a broad range of assessment paradigms from traditional stock assessment to full management strategy evaluation, and
- international best practices in the sustainable management of fisheries under the precautionary approach.

1.2.1. Security Requirements

There are security requirements associated with this requirement. For additional information, consult Part Part 6 - Resulting Contract Clauses. For more information on personnel and organization security screening or security clauses, Bidders should refer to the Contract Security Program of Public Works and Government Services Canada (http://www.tpsqc-pwqsc.qc.ca/esc-src/introduction-eng.html) website.

1.3. **Debriefings**

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing or by telephone.

PART 2. - BIDDER INSTRUCTIONS

2.1. Standard Instructions, Clauses and Conditions

As this solicitation is issued by Fisheries and Oceans Canada (DFO), any reference to Public Works and Government Services Canada or PWGSC or its Minister contained in any term, condition or clause of this solicitation, including any individual Standard Acquisition Clauses and Conditions manual (SACC) clauses incorporated by reference, will be interpreted as reference to DFO or its Minister.

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the <u>Standard Acquisition Clauses and Conditions Manual</u> (https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The 2003 (2022-03-29) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

Subsection 5.4 of 2003, Standard Instructions - Goods or Services - Competitive Requirements, is amended as follows:

2.2. Submission of Bids

Bids must be submitted by the date, time and place indicated on page 1 of the bid solicitation.

Due to the nature of the bid solicitation, bids transmitted by facsimile to DFO will not be accepted.

2.3. Enquiries- Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than five (5) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in **Ontario**.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory

specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

2.5 Bid Challenge and Recourse Mechanisms

- (a) Several mechanisms are available to potential suppliers to challenge aspects of the procurement process up to and including contract award.
- (b) Canada encourages suppliers to first bring their concerns to the attention of the Contracting Authority. Canada's <u>Buy and Sell</u> website, under the heading "<u>Bid Challenge and Recourse Mechanisms</u>" contains information on potential complaint bodies such as:
 - Office of the Procurement Ombudsman (OPO)
 - Canadian International Trade Tribunal (CITT)
- (c) Suppliers should note that there are **strict deadlines** for filing complaints, and the time periods vary depending on the complaint body in question. Suppliers should therefore act quickly when they want to challenge any aspect of the procurement process.

PART 3. - BID PREPERATION INSTRUCTIONS

3.1. Bid Preparation Instructions

Canada requests that the Bidder submit <u>all</u> its **email** bid in separately saved sections as follows and **prior to the bid closing date, time and location**:

Section I: Technical Bid (one soft copy in PDF format)
Section II: Financial Bid (one soft copy in PDF format)
Certifications (one soft copy in PDF format)

Important Note:

The maximum size per email (including attachments) is limited to 10MB. If the limit is exceeded, your email might not be received by DFO. It is suggested that you compress the email size to ensure delivery. Bidders are responsible to send their proposal and to allow enough time for DFO to receive the proposal by the closing period indicated in the RFP. Emails with links to bid documents will not be accepted.

For bids transmitted by email, DFO will not be responsible for any failure attributable to the transmission or receipt of the email bid. DFO will send a confirmation email to the Bidders when the submission is received.

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that bidders follow the format instructions described below in the preparation of their bid:

- a) use 8.5 x 11 inch (216 mm x 279 mm), letter-sized, paper;
- b) use a numbering system that corresponds to the bid solicitation.

In April 2006, Canada issued a policy directing federal departments and agencies to take the necessary steps to incorporate environmental considerations into the procurement process Policy on Green
Procurement (https://www.tbs-sct.gc.ca/pol/doc-eng.aspx?id=32573). To assist Canada in reaching its objectives, bidders should:

- 1) use 8.5 x 11 inch (216 mm x 279 mm) paper containing fibre certified as originating from a sustainably-managed forest and containing minimum 30% recycled content; and
- use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders.

Section I: Technical Bid

The technical bid should address clearly and in sufficient depth the points that are subject to the evaluation criteria against which the bid will be evaluated. Simply repeating the statement contained in the bid solicitation is not sufficient. In order to facilitate the evaluation of the bid, Canada requests that Bidders address and present topics in the order of the evaluation criteria under the same headings. To avoid duplication, Bidders may refer to different sections of their bids by identifying the specific paragraph and page number where the subject topic has already been addressed.

Part 4, Evaluation Procedures, contains additional instructions that bidders should consider when preparing their technical bid.

Section II: Financial Bid

- A. Bidders must submit their financial bid in Canadian funds and in accordance with the pricing schedule detailed in Attachment 1 to Part 3.
- B. Bidders must submit their price FOB destination; Canadian customs duties and excise taxes included, as applicable; and Applicable Taxes excluded.
- C. When preparing their financial bid, Bidders should review clause 4.1.2, Financial Evaluation, of Part 4 of the bid solicitation; and article 6.6, Payment, of Part 6 of the bid solicitation.

PART 4. - EVALUATION PROCEDURES AND BASIS OF SELECTION

4.1. **Evaluation Procedures**

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

4.1.1. Technical Evaluation

4.1.1.1. Mandatory Technical Criteria

4.1.1.2. Point Rated Financial Criteria

Refer to Attachment 2 to Part 4. Point-rated technical criteria not addressed will be given a score of zero.

4.1.2. Financial Evaluation

For bid evaluation and Contractor selection purposes only, the evaluated price of a bid will be determined in accordance with the Pricing Schedule detailed in Attachment 1 to Part 3.

4.2 Basis of Selection – Highest Combined Rating of Technical Rating Merit (70%) and Price (30%)

- 1. To be declared responsive, a bid must:
 - (a) comply with all the requirements of the bid solicitation;
 - meet all the mandatory evaluation criteria and flexible grid scores; and (b)
 - obtain the required minimum number of points specified in Attachment 2 to Part 4 (c) for the point-rated technical criteria.
- 2. Bids not meeting 1(a) or 1(b) or 1(c) will be declared non-responsive.
- 3. The bid selection will be based on the highest responsive combined rating of technical merit and price. The ratio will be 70% for the technical merit and 30% for the price.
- To establish the technical merit score, the overall technical score for each responsive bid will be determined as follows: total number of points obtained / maximum number of points available multiplied by the ratio of 70%.
- 5. To establish the pricing score, each responsive bid will be prorated against the lowest evaluated price and the ratio of 30%.
- 6. For each responsive bid, the technical merit score and the pricing score will be added to determine its combined rating.
- 7. Neither the responsive bid obtaining the highest technical score nor the one with the lowest evaluated price will necessarily be accepted. The responsive bid with the highest combined rating of technical merit and price will be recommended for award of a contract.

The table below illustrates an example where all three bids are responsive and the selection of the contractor is determined by a 70/30 ratio of technical merit and price, respectively. The total available points equals 135 and the lowest evaluated price is \$50,000 (50).

ATTACHMENT 1 to PART 4 - FLEXIBLE GRID

For this requirement, DFO requires the services of a one (1) Senior Statistical Analyst, one (1) Senior Evaluation Services Consultant, or one (1) Senior Performance Measurement Consultant, **OR** bidders can propose a team composed of a **maximum of three (3) members** within those categories.

It is at the discretion of the bidder to determine what resource(s) may be needed to deliver the RFP requirements. Note that Bidders can propose a team composed of a <u>maximum of three (3) members</u> within the listed consultant/analyst categories.

If more than one resource is presented in the bid, it **must** be clearly articulated which proposed resource meets a given evaluation criterion (but different proposed resources could be used to collectively meet the full set of criteria).

Each category has its own flexible grid. The flexible grid indicates the minimum level of points required to qualify for each level of expertise. Various amounts of points are given for education, professional certification and relevant experience.

The Bidder's proposed resource(s) will be assessed against the relevant category's flexible grid.

Only bids with a resource combination that meets the corresponding flexible grid(s) and that meet all the mandatories will be evaluated against the point rated criteria.

1) Experience

The experience **must** be demonstrated and be directly related to the category. Suppliers should provide complete details as to where, when, month and year, and how, through which activities/responsibilities, the stated qualifications/experience were obtained. Experience gained during formal education will not be considered work experience. All requirements for work experience will be obtained in a legitimate work environment as opposed to an educational setting. Co-op terms are considered work experience provided they are related to the required services. The month(s) of experience listed for a project whose time frame overlaps that of another referenced project, will only be counted once.

The qualifications and experience of the proposed category(s) will be assessed against the requirements set out in the resulting request for proposal (RFP). The identified user may request reference information. Canada reserves the right to request references from an supplier to conduct a reference check to verify the accuracy of the information provided. Should the reference(s) not confirm the required qualifications of the proposed consultant(s) to perform the required services, Canada reserves the right to go to the next supplier.

2) Education

Academic certification (degree, etc.) **must** be obtained through a recognized academic institution in the field of expertise. Points will only be awarded for the highest level of education achieved by the proposed resource.

If applicable, the proposed resource(s) **must** meet the education requirements detailed in the RFP for the consultant category for which they are being proposed. Where the resulting RFP requests the supplier to provide information about the education of the proposed individual, the individual must have obtained its education from a recognized Canadian university, college or high school, or the equivalent as established by a recognized Canadian academic credentials assessment service, if obtained outside Canada. The list of recognized organizations can be found under the <u>Canadian Information Centre for International Credentials</u> web site.

A copy of the relevant Academic certification(s) (e.g., degree, certificate, etc.) must be submitted with the Bid.

3) Relevant professional certification

The Bidder **MUST** demonstrate that the <u>each</u> proposed resource listed below meets the minimum number of points required for the relevant level and category as described in the Flexible Grid.

Bids which fail to meet the mandatory Flexible Grid Criteria will be declared non-responsive, and will be given no further consideration. The professional certification **must** be valid and relevant to the specific consultant category. A maximum of 1 certification will receive points.

The Contractor will be reimbursed its authorized travel and living expenses reasonably and properly incurred in the performance of the Work, at cost, without any allowance for profit and/or administrative overhead, in accordance with the meal, and private vehicle allowances specified in Appendices B, C and D of the <u>National Joint Council Travel Directive</u>, and with the other provisions of the directive referring to "travellers", rather than those referring to "employees", to a limitation of expenditure of \$ [will be determined at contract award].
- 2. Canada will not pay the Contractor any incidental expense allowance for authorized travel.

- 3. All travel must have the prior written authorization of the Project Authority.
- 4. All payments are subject to government audit.

ANNEX A - STATEMENT OF WORK

1.0 Title: Review of the technical elements of Fisheries and Oceans Canada's ("DFO") A fishery decision-making framework incorporating the precautionary approach ("PA Policy", DFO 2009a)

1.1 Objective

This RFP is intended to develop key Science recommendations to support revisions to the PA Policy.

The objective of this project is obtain the services of one or more senior fisheries science analysts to provide an evaluation and statistical performance review of the technical elements of Fisheries and Oceans Canada's ("DFO") *A Fishery Decision-Making Framework Incorporating the Precautionary Approach* ("PA Policy", DFO 2009a), and technical analyses of potential revisions, additions or clarifications to the PA Policy, taking into account:

- the need to implement the PA Policy across diverse species life histories and data availabilities.
- a broad range of assessment paradigms from traditional stock assessment to full management strategy evaluation, and
- international best practices in the sustainable management of fisheries under the precautionary approach.

Actual revisions to the current PA Policy will be led by another DFO sector (Domestic Fisheries Policy), who may or may not choose to modify the policy on the basis of scientific recommendations, and who may further hold consultations with other DFO sectors, Indigenous communities, other governments, as well as the general Canadian public, all of whom may contribute suggestions and candidate revisions to the Policy. It is recognized that the work acquired through this RFP will need to be scoped such that it focuses on key areas pertinent to Science for advice on possible policy revision (rather than an exhaustive list of all possible revisions).

1.2 Background

DFO has a mandate to sustainably manage fisheries and aquaculture, among other activities. In 2009, DFO released the Sustainable Fisheries Framework, a suite of policies that provide the basis for ensuring that Canadian fisheries support conservation and sustainable use of resources. One of the policies in the Sustainable Fisheries Framework is the PA Policy (DFO 2009a), which describes a general fishery decision-making framework for implementing harvest strategies that incorporate the precautionary approach to fisheries management.

A review of the technical elements of the policy and supporting technical analyses are required to support consideration of possible updates to the PA Policy, to help ensure the policy functions as intended to support the management of Canadian key harvested fish stocks. Previous work has examined various aspects of the PA Policy and identified technical challenges, topics that might benefit from clarification and topics that might benefit from additional operational guidance (DFO 2016, DFO 2021, Marentette and Kronlund 2020).

From its outset, the PA Policy was intended to be updated periodically to ensure it remains consistent with international best practices, but has not been updated since its inception in 2009. The PA Policy will also be used as the framework with which to interpret and implement the Fish Stocks provisions of the 2019 amended *Fisheries Act*. These provisions will come into force with the prescription of major fish stocks by regulation.

To date, DFO Science has not engaged in any work related to the requirements of this RFP, save some preliminary scoping work with Domestic Fisheries Policy to ensure that work conducted under this RFP remains relevant to DFP's requirements. Specifically, DFO Science has not formed any CSAS steering committees or drafted any Terms of Reference for the peer review meetings expected

to follow from the work under this RFP. Finally, there is not (nor has there been within the past 12) months) any contracted resource performing the services described in this RFP.

2.0 Reference Documents

Note: Existing publications are foundational to this RFP and can support delivery of some requirements, but are not themselves sufficient. In fact, both DFO 2022 and DFO 2023 identify broad areas where policy improvement could be made that would need further scientific work in order to develop concrete Scientific recommendations in order to be actionable. Given the recent publication of guidance on LRPs, the work under this RFP is also more likely to focus on evaluation of Science considerations in the rationale for, formulation and/or implementation of and/or interaction among the full suite of reference points in the current PA Policy (e.g., Limit Reference Point, Upper Stock Reference, Target Reference Point, Removal Reverence).

3.0 Requirements

3.1 Scope of Work

The Project Requirements include:

- 3.1.1 Identify and analyze relative performance (i.e., advantages and disadvantages) of candidate modifications to the reference points used in the PA Policy. This includes how the reference points are defined and explained, as well as any associated provisional default values to be used for the reference points, as they relate to the objectives of the PA Policy. The range of candidate modifications to be assessed will take into account diverse life histories and data availabilities, various assessment paradigms (i.e., from traditional stock assessment to full-scale management strategy evaluation), and international best practices regarding reference points and objectives they should represent. Reference points to be analyzed include (but are not limited to) the limit reference point (LRP), removal reference (RR), upper stock reference (USR) and target reference point (TRP) of the current PA Policy.
- 3.1.2 Identify and analyze relative performance (i.e., advantages and disadvantages) of candidate modifications to the PA Policy and associated guidance on the development, implementation and evaluation of harvest decision rules (HDRs) that are aimed to meet the objectives of the PA Policy, as well as risk-equivalent provisional default rules that may be adopted as HDRs. The range of candidate modifications to be assessed will take into account diverse life histories and data availabilities, varying assessment paradigms (i.e., from traditional stock assessment to full-scale management strategy evaluation), and international best practices, and will include evaluation of the relative performance of the provisional default HDRs of the current PA Policy.
- 3.1.3 Identify and analyze the relative performance (i.e., advantages and disadvantages) of candidate modifications to the PA Policy and associated guidance for choosing risk tolerance and taking into account risk and uncertainty, including provisional default risk tolerance categories that may be provided to guide choice of management measures. The range of candidate modifications to be assessed will take into account diverse life histories and data availabilities, varying assessment paradigms (i.e., from traditional stock assessment to full-scale management strategy evaluation), and international best practices, and will include evaluation of the provisional risk tolerance categories in the current PA Policy.
- 3.1.4 Identify and analyze the relative performance (i.e., advantages and disadvantages) of candidate modifications to the PA Policy and associated guidance for taking into account environmental conditions, including climate change, in precautionary approach elements such as reference points and HDRs, and will include evaluation of time-varying reference points. The range of candidate modifications to be assessed will take into account diverse life histories and data availabilities, varying assessment paradigms (i.e., from traditional stock assessment to full-scale management strategy evaluation), and international best practices.
- 3.1.5 Identify and analyze the relative performance (i.e., advantages and disadvantages) of candidate modifications to the PA Policy and associated guidance for the management of multispecies fisheries and forage fish fisheries. The candidate modifications to be assessed will address the development and implementation of precautionary approach elements such as reference points and HDRs for these cases, and will take into account diverse life histories and data availabilities, varying assessment paradigms (i.e., from traditional stock assessment to full-scale management strategy evaluation), and international best practices. In the case of forage fish, the review will also take into account differences between the current PA Policy and DFO's *Policy on New Fisheries for Forage Species* (DFO 2009b).
- 3.1.6 Identify and analyze the relative performance (i.e., advantages and disadvantages) of candidate modifications to the PA Policy and associated guidance to clarify or update policy elements such as diagrams and the reporting and visualization of indicators used to evaluate stock and fishery

performance, in relation to the objectives of the PA Policy. This will include stock status designations of Critical, Cautious, Healthy, and 'at or above/below the removal reference', as well as indicators used in DFO's *Sustainability Survey for Fisheries* (which are used in Canada's Environmental Sustainability Indicators or CESI).

3.3. Tasks

For each requirement, the tasks include:

- 3.2.1 Complete technical literature reviews as necessary to support the identification of candidate modifications to be assessed in requirements 3.1.1 to 3.1.6. Work to finalize the list of candidate modifications will be completed in collaboration with a multi-sector DFO steering committee convened by the Project Authority.
- 3.2.2 Complete technical analyses such as closed-loop simulation as necessary to support the analysis (i.e., advantages and disadvantages) of proposed modifications identified in Step 3.2.1. Note that the number and types of closed-loop simulation required by the project have not been determined yet.
- 3.2.3 Support the development of, lead and/or participate in meetings and/or workshops with client sectors (fisheries management, strategic policy) to elucidate objectives, understand implementation needs, and/or communicate the results of technical reviews and analyses.
- 3.2.4 Provide results of both literature reviews and closed-loop simulations in the form of one or more technical papers that may be submitted for peer review, e.g., through the CSAS office. Note that the number and types of closed-loop simulation required by the project have not been determined yet.
- 3.2.5 Presentation and defense of, and subsequent completion of, technical papers submitted for peer review, e.g., through the CSAS office. This includes post-review revisions required for research document publication.

3.3 Deliverables and Acceptance Criteria

The deliverables and acceptance criteria include:

- 3.3.1 Attendance at progress review meetings including the Contractor and the Project Authority at least once per month for the duration of work until deliverable 3.2.3 is met. Specific deliverables for each progress review meeting will be determined at the close of the preceding progress review meeting, and may include (but are not limited to) outlines, presentations, short discussion papers, worked examples, etc.
- 3.3.2 Presentation materials, including but not limited to PowerPoint files and open-source software tools, to support progress meetings and workshops as necessary.
- 3.3.3 One or more technical papers containing the full suite of reviews, analyses and recommendations for requirements 3.1.1 to 3.1.6, provided in a form that may be submitted for peer review, i.e., working paper(s) according to the formats required by DFO's CSAS office.
- 3.3.4 Presentation materials, including but not limited to PowerPoint files and open-source software tools, to support peer review of the technical papers.

4.0 Travel Requirements

4.1 It is anticipated that a maximum of one in-person meeting will be required per project requirement (i.e., up to six in-person meetings in total for the project). Each meeting is expected to be 4-5 days in

duration and take place in a centralized location depending on participation (e.g., Ottawa, Montreal, Vancouver).

4.2 Meeting arrangements will be at the discretion of the Project Authority. It is expected that CSAS review meetings will be the only meetings for which travel may be required.

5.0 Department obligations

Canada's roles and responsibilities will be to supply information, data and reference material as required to complete the reviews and analyses. Specifically, this will include any material relevant to the work that is not publicly available, such as draft reports, unpublished documents, proposed policy options for evaluation, other policy information, etc.

6.0 Timeframe and delivery dates

- a) Timeframe: Overall timelines for deliverables associated with each project requirement will be established by mutual agreement of the Contractor and the Project Authority, and may be subject to change based on operational needs. A delivery schedule for RFP milestones will be developed between the contractor and Project Authority.
- b) Timeframe: Project requirements may not be addressed in the sequence presented. The Contractor may be required to work on two or more project requirements concurrently at the discretion of the Project Authority.

7.0 Location of Work

The Work must be completed using the Contractor's equipment and at the Contractor's place of business. The Work will be complete remotely, unless virtual meetings or workshops are considered infeasible at the discretion of the Project Authority.
