Answer the following question from Industry:

Question 1:

Our manufacturers are based in the US and we would like to know if there is any exchange rate protection for this bid? Not having this protection in place puts us at a disadvantage since we will have to add a percentage to protect us from variations.

Response 1:

Canada is not considering exchange rate fluctuation for this requirement. This is addressed at Section 3.1.2 of the Bid Solicitation, SACC Manual Clause C3011T - Exchange Rate Fluctuation:

"The requirement does not offer exchange rate fluctuation risk mitigation. Requests for exchange rate fluctuation risk mitigation will not be considered. All bids including such provision will render the bid non-responsive".
