Public Services and Procurement Canada (PSPC) is asking interested parties to provide information for potential parcels of land for sale that meets the following criteria:

**Section A: Land Components**

- Interested parties may submit information for parcels of land ranging in size from a minimum of 100 hectares to 1200 hectares.
- Lands may be presented as individual or assembled parcels.
- The proposed lands must be located within the following boundaries:

North: Trans-Canada Highway within the Provincial border of Ontario  
South: Provincial border of Ontario  
East: Provincial border of Ontario  
West: Provincial border of Ontario

Note: PSPC, as the Office of Primary Interest (OPI), or other government agents, may wish to visit or inspect the proposed lands upon reasonable notice.

PSPC reserves the right to proceed with an Invitation to Offer to Purchase by inviting only parties deemed to most effectively meet specific operational, security and public safety requirements.
