The solicitation is hereby amended to provide the following questions and answers:

Question 1

1000505198

Given the duration of the contract and work required, would the VAC consider an alternative Schedule of Payments (6.8.1)? Ideally, a monthly payment schedule or one which reflects incremental work stages.

Answer 1

The schedule of milestones outlined in 6.8.1 reflects incremental work stages whereby a payment will be issued after the completion of Steps 1-4. No changes to the payment schedule will be made.

Question 2

Based on the scope provided, are we right in understanding that the only in person meeting attendance would be for the site visit to France for orientation / initial workshops? Can we suggest other in-person workshops (location t.b.c) if this would be of benefit to the commission?

Answer 2

Yes, only one site visit to France for orientation / initial workshops is required. There isn't a requirement for additional on-site/in-person meetings.

Question 3

Can any alteration be made to the order in which tasks are conducted, in particular, Step 4 (Target Audience Identification) would appear to be needed to inform 3B

Answer 3

Yes, it is acceptable to alter the order in which tasks within Steps 1 -4 are completed.

Question 4

Step 8- can you provide further clarification on what is meant by 'promotional actions'? Does this refer to Marketing Strategy?

Answer 4

Promotional actions refers to the promotional tools and techniques being recommended for implementation to increase awareness of our services. It does not refer to a Marketing Strategy.

Question 5

Can you provide further definition and detail regarding the VAC team members involved in the commission – roles and location.

Answer 5

Veterans Affairs Canada team members are located in Charlottetown, Prince Edward Island,

Question 6

Mandatory Technical Criteria - Roles
