## AMENDMENT #1

---

This amendment is made in response to question #1 of questions and answers #2.

**A. Paragraphs 2.4.1 of Section 2.4 “Basis of Selection – Highest Combined Rating of Technical Merit 70% and 30% Price” is deleted in its entirety and replaced with the following:**

2.4.1 To be declared responsive, a bid must:

- (a) comply with all the requirements of the bid solicitation;
- (b) meet all the mandatory evaluation criteria;
- (c) obtain the minimum number of points specified in RT3 in Attachment 1 to Part 4.
- (d) meet all of the mandatory financial evaluation criteria

**B. Paragraph 2.4.2 of Section 2.4 “Basis of Selection – Highest Combined Rating of Technical Merit 70% and 30% Price” is deleted in its entirety and replaced with the following:**

2.4.2 Bids not meeting (a) or (b) or (c) or (d) will be declared non-responsive. Neither the responsive bid obtaining the highest number of points nor the one with the lowest evaluated price will necessarily be accepted.

**C. All other conditions remain unchanged.**
