Yes, a standard 1-year warranty is required for the first year as per SACC 2010A Section 9: Warranty.

The total number of optional years of extended warranty that needs to be quoted after the standard warranty is 4 years (See Appendix 1 to Annex A, Table 3). The Option Period 1 will cover the warranty for 12-24 months, Option Period 2 will cover 24-36 months, Option Period 3 will cover 36-48 months, and Option Period 4 will cover 48-60 months. The quote for the optional years of extended warranty must be added in Table 2: Optional Procurements at page 56 of 88.
