1. The solicitation is hereby amended to provide the following questions and answers and to update Annex A – Statement of Work.

Question 13

May I request a link to 6.7.2 National Joint Council Travel Directive because there does not seem to be a link from the PDF.

Question 14

If we have staff near to the sites – how should we reflect this in the proposal due to cost savings in travel arrangements that may provide us with a competitive advantage over other bidders?

Answer 14

The rates proposed for 6.7.1 - Basis of Payment are for the lot fees for completing the Work, exclusive of any travel costs regardless of the location that the Contractor's resources are traveling from.

Contractor's will be paid for its authorized travel and living expenses reasonably and properly incurred in the performance of the Work done, delivered or performed outside Canada as cost, without any allowance for profit and administrative overhead, in accordance with the meal and private vehicle expenses provided in Appendices B, C and D of the <u>National Joint Council Travel Directive</u>; and with the other provisions of the directive referring to "travellers", rather than those referring to "employees", to a limitation of expenditure of \$20,000.00. Customs duty are included and Applicable Taxes are extra.

The authorized travel and living expenses will be paid upon submission of an itemized statement supported by receipt vouchers. All payments are subject to government audit.

As per 4.1.1.3 of the Request for Proposal, the evaluated price will exclude any costs for Travel and Living Expenses.

Question 15

Mandatory Technical Criteria – To qualify are bidders required to meet all the criteria requested in the form, specifically MT5? Will consultants who have experience in park assessments other than National Parks or National Historic Sites qualify?

To be declared responsive, the Bidders must meet all the Mandatory Criteria outlined in Annex C Mandatory Technical Criteria. Experience in completing park assessments for locations other than National Parks or National Historic sites will not be deemed compliant to meet the requirements of MT5
